- **Grade 2** will enter through **Entrance/Exit 6** (on Third Street) at 8:20 a.m. by classroom. Breakfast is served in the classroom.
- **Grade 3 Annex A** will line up at 8:20 a.m. by classroom at Annex A & B courtyard and enter through the 259 Fulton Street main entrance. Breakfast will be served in the classroom. (There will be marked cones.)
- **Grade 4 Annex B** will line up at 8:20 a.m. by classroom at Annex A & B courtyard and enter through the 249 Fulton Street main entrance. (There will be marked cones.) Students eating breakfast must check in at 8:00 a.m. at Annex A main entrance. **Breakfast will be served for Grade 4 at Annex A (259 Fulton Street).**
- **Grade 5 Annex B** will line up at 8:20 a.m. by classroom at Annex A & B courtyard and enter through the 249 Fulton Street main entrance (There will be marked cones). Students eating breakfast must check in at 8:00 a.m. at Annex A main entrance. **Breakfast will be served for Grade 5 at Annex A (259 Fulton Street).**
- **Grades 6-8** will enter through the **Main Entrance/Exit 5** (Third Street) at 8:20 a.m. by classroom. (The fence will be labeled by class.) Students eating breakfast must check in at 8:00 a.m. at our main door, Exit 5.

#### **DISMISSAL:**

- **Grades K & 1** will dismiss at 2:57 p.m. through **Exit 4**.
- **Grade 2** will dismiss at 2:57 p.m. through **Exit 6**.
- **Grades 3** Annex A will dismiss at 3:00 p.m. through Annex Main Entrance/Exit Door.
- **Grades 4 & 5** Annex B will dismiss at 3:00 p.m. through Main Entrance/Exit Door.
- **Grades 6-8** will dismiss at 3:00 p.m. through **Exit 5**, Main Entrance.

### **POWERSCHOOL PARENT PORTAL INSTRUCTIONS**

PowerSchool is an electronic management system that is utilized by the Elizabeth Public Schools in order to collect, store, and maintain pertinent student data and records. The application provides parents with real-time access to information that pertains to a student’s schedule, attendance, grades, and academic progress; it also offers a convenient and accommodating way for both parents and teachers to communicate as needed. Therefore, everyone stays connected. Schedules for the upcoming 2024-2025 school year will be available to view on PowerSchool on **Thursday, August 29<sup>th</sup>**.

#### NEW AND RETURNING PARENTS TO EPS

Parents of new students must request a new account in order to input all of the information required to navigate the PowerSchool Parent Portal. Parents of existing students will need to log in, input, and update any changed information that has occurred for their child.

### **IMMUNIZATION REQUIREMENTS**

The state of New Jersey has mandated that all children born after January 1<sup>st</sup>, 1997 and enrolled in Grade Six, **will be required to receive a booster dose of the diphtheria, tetanus and pertussis vaccine (Tdap) as well as one dose of meningococcal vaccine.** Documentation that your child has received the required sixth grade immunizations must be turned into the school nurse no later than *Friday, September 6, 2024*.

Students entering 6<sup>th</sup> grade with birthdays on or after *Friday, September 6<sup>th</sup>, 2024* must provide written confirmation from your child’s healthcare provider of the vaccination appointment. This appointment should be within two weeks of your child turning 11 years of age. The immunization record must be submitted immediately following the appointment. The Elizabeth Public School District is compelled by law to ensure that all students receive their required immunizations.

**Children who do not meet immunization requirements or do not have documentation of a scheduled appointment within two weeks of turning 11 years of age will be excluded from school beginning the first school day.**

### **TRANSPORTATION**

Transportation will be available for the following students:

- Elementary students who live more than 2.0 miles from their school
  - High school students who live more than 2.5 miles from their school
  - Students whose IEP include transportation services
