The next team to place consisted of Captain Rahyan Mahmoud, Florencia Curbelo, Auraniza Monsalve, Chanel Arenciba, Ahmed Nagy, Jayana Torres, and Cristian Villa. Their challenge was an improvisational challenge where the team had to take a news story with which they were familiar, and connect it, through a cause and effect relationship to another news story given to them four minutes before their performance. Then, another bizarre "glitch" was thrown at the team. They had to combine all of those elements and produce an improvised skit. For this team's fast-on-their feet thinking, about melting snowmen on their way to Norway to watch bad soccer games, they earned a second place finish.

Captain Cecile Requiste along with Michelle Umana, Sade Chico, Pam Castillo, Harold Ramirez, and Sirena Soto won a first place victory in a challenge asking them to use different lighting techniques in pitch blackness to demonstrate the principles of solar energy. This they did with a creative and fun story about a crime-ridden city saved by an unusual application of solar power. Riding the manic energy of Cecile's crazed newscaster, Michelle's hilarious interpretation of an energized cop, and Pam Castillo's singing voice, this team beat all-comers and earned their invitation to Global Finals.
