BOARD OF EDUCATION (Official)

January 18, 2018 Elizabeth, New Jersey

The regular agenda meeting of the Board of Education was called on January 18, 2018 at 5:30 p.m., at Dr. Martin Luther King, Jr. Center for Early Childhood Education School No. 52, 130 Trumbull Street, Elizabeth, New Jersey.

Board President Maria Carvalho welcomed everyone at 5:45 p.m. to Dr. Martin Luther King, Jr. Center for Early Childhood Education School No. 52. Mrs. Carvalho stated that the opening performances and presentations would be held prior to the agenda meeting.

Present for the opening performances and presentations were Mrs. Barbosa (arr. 6:00 p.m.), Ms. Bathelus (arr. 6:03 p.m.), Miss Goncalves, Mr. Jacobs, Mrs. Moreno-Ortega, Mr. Nina, and Mrs. Carvalho.

Mrs. Carvalho thanked the students for a wonderful performance.

Mr. Nina recognized Liberty Hall Museum Director Bill Schroh and acknowledged the donation from Liberty Hall Museum to defray students' cost to tour the museum. Mr. Nina and Board members thanked Director Bill Schroh and presented Liberty Hall Museum with a plaque of commemoration.

Board President Maria Carvalho presented the following statement at 6:25 p.m.

"Ladies and Gentlemen, good evening. This is a regular agenda meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth on January 12, 2018. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth, New Jersey.

"We want to welcome everyone present and our television viewers to this January 18, 2018 meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public.

"This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. We also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, we may have to ask for order periodically should noise begin to interfere with our recording capabilities. We are pleased that you have taken time this evening to join us here for our Board of Education meeting. Thank you for your interest in the Elizabeth Public Schools."

"There will be a public portion for citizens to address the Board. Participants for the public portion may sign in up to the start of the public speaking so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Superintendent of Schools Olga Hugelmeyer, School Business Administrator/Board Secretary Harold E. Board President Carvalho presented the following public participation statement.

No individual is able to yield their time to another individual.

The following rules for public participants shall apply: time limits will be strictly enforced, no personal attacks on individuals, no vulgar or indecent language, a person may address the Board no more than once during a single meeting, speakers should refrain from naming individuals, and comments or questions posed during public participation will not be debated. As a reminder, this is a meeting of the Board in public, not a meeting of the public."

Mrs. Carvalho called upon the first public participant, Carlos Torres, to address the Board.

Carlos Torres, 156 Broadway, Councilman 1st Ward, thanked the Board for the quick response to the Stuff the Bus project to help Puerto Rico.

Mrs. Barbosa returned to the meeting at 6:30 p.m.

Mrs. Carvalho thanked him for his comments and called upon the next public participant, Maria Medeiros DaRassi, to address the Board.

Maria Medeiros DaRassi, 420 Fay Avenue, spoke about bullying being out of control.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Maria Lorenz, to address the Board.

Maria Lorenz, 103 Murray Street, spoke about special education and SEPAC and asked the Board members where is the change you all talked about.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, John Loprieto, to address the Board.

John Loprieto, district math teacher, stated that what works is working with the students every day. Mr. Loprieto stated that what doesn't work is that when you put in applications for jobs that are open and there are no interviews.

Mrs. Carvalho thanked him for his comments and requested he speak with Chief of Operations Francisco Cuesta.

Since there were no other public participants signed in to address the Board, Mrs. Carvalho closed this portion of the meeting.

Board President Carvalho stated that this is an agenda setting meeting. Mrs. Carvalho stated that we will go tab by tab and each Board member may ask questions. Assistant Superintendent for Schools Rafael Cortes stated that there are 56 trips requested of which 26 are for high schools. Mr. Cortes stated that 16 of the trips are to visit colleges and universities and 10 are to various museums.

Mrs. Carvalho added the report to the agenda.

Superintendent's Report – Harassment, Intimidation and Bullying Investigative Results

Mrs. Hugelmeyer spoke on behalf of Director of Early Childhood Education Tracy Crosby on the expansion of services of the Catapult Before and After Care Program to kindergarten students at all K-8 schools, district-wide, for the 2018-2019 school year. Mrs. Hugelmeyer stated that this will allow working families to apply for before and after care services through the Division of Human Services to continue to receive child care after exiting the preschool program.

Mrs. Carvalho added the report to the agenda.

Mrs. Carvalho asked if there were any questions.

Mrs. Carvalho added the report to the agenda.

Award of Contracts Report

Mrs. Hugelmeyer requested Director of Plant, Property, and Equipment Luis Couto speak about the contracts for architectural services.

Director of Plant, Property, and Equipment Luis Couto explained that there are four contract awards for architectural services and this work will put us on the list for the Department of Education for a new school due to the large enrollment that we have.

Mrs. Carvalho asked what is the turnaround.

Mr. Couto explained the process.

Mrs. Hugelmeyer requested Director of Bilingual and ESL Education Sandra Nunes speak about the contract with 10 Hairy Legs Co.

Director of Bilingual and ESL Education Sandra Nunes stated that we are always looking for ways to expose our students to the performing arts. Mrs. Nunes stated that this company will be working with the music teachers at four schools to provide them with professional development and will have dance sessions for second grade students. Mrs. Nunes stated that there will be a culminating performance.

Mrs. Carvalho added the report to the agenda.

Supplemental Award of Contract Report

Mrs. Carvalho asked if there were any questions.

Mrs. Hugelmeyer requested Acting Director of Athletics Bartolomeo Candelino speak about the athletic contract.

Acting Director of Athletics Bartolomeo Candelino stated that there is a contract for Spring athletic equipment and supplies for baseball, softball, boys' volleyball, outdoor boys' and girls' track and middle school programs. Mr. Candelino stated that we select the lowest bidder as long as the product is similar.

Ms. Bathelus asked for a synopsis of what he has done so far in the Athletic Department since he has taken over.

Mr. Candelino gave a quick synopsis and stated that he met with all of our coaches for Fall and Winter and has already met with our Spring coaches. Mr. Candelino stated that he explained to them what we thought as a Board and as a District what we wanted from our coaches and the type of dedication that he thinks we need from our coaches for our student athletes moving forward. Mr. Candelino stated that he explained to the coaches that there is an emphasis not only on winning and competing but also being there for our student athletes for college and scholarships. Mr. Candelino stated that they have increased a few of the middle school programs including an additional girls' seventh and eighth grade basketball team, an additional boys' volleyball team, posted for a tennis coach and seventh and eighth grade golf coach.

Mrs. Hugelmeyer requested Director of Instruction and Curriculum Aaron Goldblatt speak about the contract with Southern New Jersey Perinatal Cooperative.

Director of Instruction and Curriculum Aaron Goldblatt stated that vaping definitely poses a threat to our students and is highly addictive. Mr. Goldblatt stated that the Southern New

Jersey Perinatal Cooperative will be conducting several presentations on vaping at the high schools.

Mrs. Carvalho asked if we have a lot of students vaping.

Mr. Goldblatt stated that he does not know but the tobacco industry is focusing on this.

Miss Goncalves asked if it will include ninth grade students.

Mrs. Hugelmeyer stated that ninth graders are being included in this initiative.

Mrs. Carvalho added the report to the agenda.

Mr. Kennedy requested the following be added to the agenda:

First Reading of Revised Title I Policy and Board Workshop Calendar Regulation

Mrs. Carvalho added the First Reading of the Revised Policy and Regulation to the agenda.

Ms. Bathelus asked if the lunch prices changed and when.

Director of Food and Nutrition Services Jamie Leavitt stated that the prices changed on January 1.

Mrs. Hugelmeyer introduced Director of Research, Evaluation and Assessment Amy Gil to present the Accountability, Every Student Succeeds Act and School Performance Reports.

Director of Research, Evaluation and Assessment Amy Gil presented the Accountability, Every Student Succeeds Act and School Performance Reports. Mrs. Gil stated the history of the accountability in New Jersey including the No Child Left Behind (NCLB), Elementary and Secondary Education Act (ESEA) and the current Every Student Succeeds Act (ESSA). Mrs. Gils stated that the No Child Left Behind (NCLB) included categories for Districts in Need of Improvement and Schools in Need of Improvement, then came the Elementary and Secondary Education Act (ESEA) with categories for Reward Schools, Focus Schools, and Priority Schools. Mrs. Gil stated that the current Every Student Succeeds Act has categories for Schools in Need of Targeted Support and Schools in Need of Comprehensive Support. Mrs. Gil presented a PowerPoint slide showing the history of accountability in Elizabeth for NCLB from 2004-2005 through 2010-2011, ESEA from 2011-2012 through 2017-2018, and ESSA. Mrs. Gil stated that as we transition the accountability measures change and now we only have two schools identified by the New Jersey Department of Education as in need of some level of support.

Mrs. Gil stated that New Jersey's Every Student Succeeds Act school accountability system provides a formula to determine a summative performance score which is based on various measures of progress and the schools have been identified as targeted or comprehensive based on their relative low performance using these measures. Mrs. Gil stated that a Comprehensive School is a school performing at or below the fifth percentile of all Title I schools based on summative score. Mrs. Gil stated that a Targeted School is a school with a subgroup performing at or below the bottom 5% threshold of Title I schools. Mrs. Gil stated that the accountability indicators in the ESSA state plan measure the progress of schools as they prepare students for a successful life after high school. Mrs. Gil stated that the stakeholders including NJ parents and educators statewide provided input in New Jersey's ESSA State Plan. Mrs. Gil stated that the indicators include academic achievement, academic growth, graduation rate, English language proficiency, and chronic absenteeism. Mrs. Gil stated that each indicator is weighted to determine a summative score for the school and within each indicator, student groups and total population are weighted equally to determine the school's summative score. Mrs. Gil stated that students can be in more than one subgroup. Mrs. Gil explained a PowerPoint slide showing an example of the school subgroup weighting for math proficiency in Elizabeth.

Mrs. Gil stated that under the New Jersey Every Student Succeeds Act Plan long-term targets include academic achievement and growth. Mrs. Gil stated that the academic achievement is that by 2030, which is this year's kindergarten, at least 80% of all students and at least 80% of each demographic group in each tested grade will meet or exceed grade-level expectations on the statewide English language arts and mathematics assessments. Mrs. Gil stated that the growth goal is that 100% of all students will be approaching, meeting, or exceeding expectations (levels 3, 4, 5) by 2030 and 20% of all students and subgroups will be exceeding expectations (level 5) by 2030. Mrs. Gil stated that the New Jersey ESSA Plan long-term targets include that by 2030, based on adjusted cohort graduation rate methodology, 95% of all students and each subgroup of students will graduate within 4 years of entering ninth grade and 96% of all students and each subgroup of students will graduate within 5 years of entering ninth grade. Mrs. Gil stated that another long-term target is that New Jersey's goal for English language proficiency is that by 2023 86% of English learners in each school will make expected annual progress toward attaining English language proficiency.

Mrs. Gil stated that the ESSA Accountability Profiles for 2016-2017 include district profiles and school profiles, and indicators including state assessment participation, state assessment performance, academic progress, graduation rate for high school, chronic absenteeism, and English language progress. Mrs. Gil stated that the 2016-2017 accountability profiles include students whose time in school is greater than one year (entered prior to July 1, 2016), grades 3-8, and grades 9 and 10. Mrs. Gil stated that the student growth indicators include students in grades 4-8 for English language arts and grades 4-7 for mathematics. Mrs. Gil stated that the graduation rate for 4 years was from 2015-2016 and the graduation rate for five years was for 2014-2015. Mrs. Gil stated that chronic absenteeism includes students enrolled at the end of the school year and students with at least 45 days of membership. Mrs. Gil stated that the participation rate is no longer an indicator itself and the law requires states to factor participation rate into the measure of academic achievement. Mrs. Gil stated that chronically absent is the percentage of students in school and in each demographic group who were absent for 10% or more of the days for which they were enrolled in the school based on students enrolled at the end of the school year with at least 45 days in membership. Mrs. Gil stated that the statewide average of students enrolled in grades represented in the school who were absent 10% or more of the days for which they were enrolled. Mrs. Gil stated that when calculating chronic absenteeism there are only three areas that are excluded from the calculation, Bring Your Children to Work Day, religious holidays approved by the NJ DOE, and up to 3 college visits per year for students in grades 11 and 12 only.

Mrs. Gil stated that the 2016-2017 New Jersey Department of Education School Performance Reports include one page summary reports with easy to understand overviews of school and district performance and that new data has been added to all versions of the reports. Mrs. Gil stated that the School Performance Reports include an overview, demographic, academic achievement in English language arts, mathematics, and science, student growth for elementary school reports, college and career readiness, grad/postsecondary for high school reports only, climate and environment, staff, accountability, and narrative. Mrs. Gil explained PowerPoint slides showing accountability indicator scores and summative ratings and the Elizabeth summative ratings for elementary schools and the high schools.

Mrs. Hugelmeyer thanked her for her report.

Ms. Bathelus excused herself form the meeting at 7:32 p.m.

Mrs. Hugelmeyer stated that the state released the information on January 8 and we presented this information to all of our principals for them to share the information with our schools. Mrs. Hugelmeyer stated that we will provide an update as to how we are addressing this.

Mrs. Carvalho thanked her for the report. Mrs. Carvalho stated that she has office hours on Tuesday nights and all the Board members have office hours. Mrs. Carvalho stated that the Student Advisory Council will be meeting. Mrs. Carvalho stated that the management oversight workshops are beginning in February starting with Human Resources.

Mrs. Carvalho stated that there will be two new Ad Hoc Committees. Mrs. Carvalho stated that the Ad Hoc Ancillary Services Committee will include Chairperson Jose Rodriguez, and Board members Jerry Jacobs and Stanley Neron. Mrs. Carvalho stated that the Ad Hoc Emergency Communication and Management Services Committee will include Chairperson Daniel Nina and Board members Diane Barbosa and Stanley Neron.

Mrs. Carvalho stated that the President's Tour will continue. Mrs. Carvalho stated that they would like to bring a mobile command unit to register students for pre-kindergarten on Tuesdays and Thursdays. Mrs. Carvalho congratulated Board member Stanley Neron on the birth of his healthy baby boy. Mrs. Carvalho recognized EEA President Joe Cortico and former Board President Carole Cascio who were in attendance.

The President requests a motion to go into Private Session to consider matters exempt under the Open Public Meetings Act, specifically for discussion of personnel, specifically, N.G., reorganization, and interviews; legal, specifically, settlement agreements C.S., C.F., E.C., J.S., L.H., V.S., Grievance – non-renewed teacher sick days, and appointment of professional services; and workers' compensation claims, specifically, S.S., M.V., and S.W. The Board will reconvene in public to add to the agenda.
