BOARD OF EDUCATION (Official)

December 16, 2010 Elizabeth, New Jersey

The regular meeting of the Board of Education was called on December 16, 2010 at 7:00 p.m., in the Multi Purpose Room, Donald Stewart Center for Early Childhood Education, 544 Pennsylvania Avenue, Elizabeth, New Jersey.

Board President Carlos Trujillo presented the following statement at 7:40 p.m.

"Ladies and Gentlemen, good evening. This is a regularly scheduled meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth on Friday, December 10, 2010. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth."

"I wish to extend a warm welcome to everyone present and to our television viewers to this December 16, 2010 meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public."

"This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. I also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, I may have to ask for order periodically should noise begin to interfere with our recording capabilities. I am pleased that you have taken time this evening to join us. Thank you for your interest in the Elizabeth Public Schools."

Participants for the public portion must sign in one hour prior to the advertised start of the meeting so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Mr. Trujillo stated that it is with great sadness that we mourn the loss of Cheryl Marshall, a beloved colleague and school psychologist, who was known for her spirit of generosity and hope that she shared with young people and adults alike. Mr. Trujillo then called for a moment of silence.

Colors were presented during the Flag Ceremony by members of the Admiral William F. Halsey, Jr. Leadership Academy Marine Corps Junior R.O.T.C., followed by the Pledge of Allegiance led by Alyamise Hankins, seventh grade student at William F. Halloran School No. 22 @ 31.

The *Star-Spangled Banner* by Francis Scott Key was performed by the William F. Halloran Jazz Choir.

The Pledge of Ethics was led by Ckaane Jeffries, seventh grade student at William F. Halloran School No. 22 @ 31.

Mr. Trujillo introduced a video presentation of the Core Beliefs and Commitments.

Mr. Trujillo introduced students from the William F. Halloran Jazz Choir who performed *Little Drummer Boy* by Jay Althouse and *Up on the House Top* by B.R. Hanby. Mr. Trujillo thanked the students for the wonderful performance.

Mr. Trujillo stated that on behalf of the Elizabeth Board of Education the Lifetime of Excellent Achievements Award is presented to Felipe Gomez for his efforts in the defense of education, truth and freedom. Mr. Trujillo stated that Felipe Gomez was a Cuban patriot and civic leader who dedicated his life to civic service and promoting freedom in his native country of Cuba and that he was an eloquent orator who spoke often in defense of truth, freedom, and the value of education. Mr. Trujillo stated that this resolution speaks well to a relationship that is very important, and that it is very important that those who educate our children understand that our children come from diverse backgrounds and groups from all over the City. Mr. Trujillo stated that when they leave school, although they may be safe in our schools and we strive to make sure they are, often the streets that surround our schools are not as safe as we would like them to be. Mr. Trujillo stated that last month he spoke about a letter he received on behalf of the Union of the local Police Department and the Superior Officers Union and in that letter we were reminded of the dangers that surround our children every day and were reminded of our responsibility, not just

as Board members, as members of the community but as parents. Mr. Trujillo stated that we have a commitment to children and we must continue at all costs to continue to advocate on their behalf. Mr. Trujillo stated that to this day I know there was a meeting with the Prosecutor of Union County who happens to be the highest ranking police enforcement body in Union County, that Mr. Romankow has had a good relationship with us, he has allowed us to sit at the table and express our concerns because he shares our concerns, that he knows what we have known for a long time, that there is a gang problem in the City of Elizabeth and everything associated with gangs, gun violence, brutality, drugs, bullying. Mr. Trujillo stated that there is only so much the Elizabeth School Board can do, that we can hire the best counselors, the best educators, the best administrators but it takes the whole community to resolve this issue. Mr. Trujillo stated that too often we look to the leaders of this City, the Council people and the Mayor of this City for guidance and help on this issue, and that he will continue to challenge them to recognize that the City of Elizabeth has a gang problem and that by recognizing this problem the resources will follow. Mr. Trujillo stated that the problem is too serious to ignore and he will continue to challenge them to admit it, that they can no longer ignore it, that we see it in our kids, and it is starting to spill into our schools and it is too serious of a problem to continue to ignore. Mr. Trujillo stated that the letter validates what we already know and the great concern is that these are the police officers who are telling us we have a problem, the same police officers whose director, Mayor and City Council, do not see a problem, so that there is a disconnect on that side of the fence. Mr. Trujillo stated that he does not want to politicize this, that he has no intention of having a public battle with the police union or its leaders or with the Mayor and City Council. Mr. Trujillo stated that he is a resident of this City and raising two small children in one of the worst neighborhoods in the City which for too long lacked all the resources and is most affected and that he worries for his children and their future and for the neighborhood that he lives in. Mr. Trujillo stated that if this is not addressed soon we will be all to blame and tonight he is going to say to all those here and those at home who are watching, call your City Council and call the Mayor of the City of Elizabeth and let them know what we all know, that there is a gang problem in the City of Elizabeth and we need you to recognize it and we need you to lead and this is when leaders step up to the plate and make a difference. Mr. Trujillo stated that ignoring it will not make it go away and that he will not let this be ignored.
