The regular agenda meeting of the Board of Education was called on December 17, 2018 at 5:30 p.m., in the MultiPurpose Room, Donald Stewart Center for Early Childhood Education School No. 51, 544 Pennsylvania Avenue, Elizabeth, New Jersey.

Board President Maria Carvalho presented the following statement at 5:50 p.m.

“Ladies and Gentlemen, good evening. This is a regular agenda meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth on December 5, 2018. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth, New Jersey.”

“We want to welcome everyone present and our television viewers to this December 17, 2018 meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public.”

“This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. We also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, we may have to ask for order periodically should noise begin to interfere with our recording capabilities. We are pleased that you have taken time this evening to join us here for our Board of Education meeting. Thank you for your interest in the Elizabeth Public Schools.”

“There will be a public portion for citizens to address the Board. Participants for the public portion may sign in up to the start of the meeting so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment.”

Mrs. Carvalho called for a moment of silence for the passing of Madelynn Anabella Rizzo, fourth grade student at Woodrow Wilson School No. 19 and Carmenza Rodriguez, custodian at Nicholas S. LaCorte – Peterstown School No. 3.

Mrs. Carvalho stated that this is her last meeting as President of the Board. Mrs. Carvalho thanked her colleagues on the Board for providing her with this special opportunity to serve as the president of this Board. Mrs. Carvalho stated that it has been a very rewarding year and she looks forward to serving with them in 2019 as we continue the important work of providing Elizabeth students with a high quality education that prepares them for college and career success. Mrs. Carvalho stated that as our Board will consist of new Board members in 2019 she would like to recognize two of the members who will not be here next year and have supported her throughout their years together, Dan Nina and Jose Rodriguez. Mrs. Carvalho stated that not only have they been great colleagues and supporters during our work on the Board but they have also been great friends. Mrs. Carvalho stated that we have made tremendous progress over the past several years as a Board and as a school district which would not have been possible without their contributions. Mrs. Carvalho stated that the residents of the Elizabeth community and the children of the Elizabeth Public Schools have benefited from their dedication and dedicated service and thanked them for all they have done for this community and our schools.

Mrs. Carvalho thanked the Superintendent, members of central administration, and the rest of our team members throughout the Elizabeth Public Schools for their outstanding support during this year. Mrs. Carvalho stated that it was such a privilege to meet them and witness the outstanding work they are doing for Elizabeth's children. Mrs. Carvalho thanked the students for making these past twelve months such an awesome experience. Mrs. Carvalho stated that she wanted this year to be the year of our children and it was wonderful to be part of so many of their inspiring achievements. Mrs. Carvalho stated that among the memorable achievements was addressing the 2018 graduates and being on stage when her son Dylan walked up to receive his diploma. Mrs. Carvalho thanked her family for making tremendous sacrifices and their endless support that allowed her to do this important work. Mrs. Carvalho stated that the work they do is different and many people don't understand but if you sit here in our shoes, you give up a lot of family time and time that you can dedicate to your family. Mrs. Carvalho stated that they do this with heart and with passion. Mrs. Carvalho wished everyone a safe, healthy and happy holiday season on behalf of the Elizabeth Board of Education and stated let's continue to do great things together in 2019.

Mr. Neron recognized former Board member Jose Rodriguez for his many years of dedicated service, his support, undying knowledge of education and undying advocacy for our children in the City of Elizabeth Public School District. Mr. Neron stated that it is a sad moment for him because he was his running mate and the person that he worked very hard with to get on this Board of Education. Mr. Neron stated that they went through many trials and tribulations and it was in this room that they were interviewed to fill a vacant seat on the Board but they did not get that. Mr. Neron stated that we showed the citizens of Elizabeth that we could do this and we stand for the City and the children of the City of Elizabeth. Mr. Neron commended Mr. Rodriguez for his many years of hard work, partnership, loyalty, and friendship. Mr. Neron read the plaque stating that the Elizabeth Board of Education hereby recognizes Jose Rodriguez for his years of dedicated service to the students of the Elizabeth Public Schools as a member of the Elizabeth Board of Education. Mr. Neron stated that they will miss him dearly. Mr. Neron and Board members congratulated and thanked Jose Rodriguez for his years of service and presented him with a plaque of commemoration.

Mr. Rodriguez thanked his Board colleagues and stated that he truly appreciates this. Mr. Rodriguez stated that it is hard to believe that for a better part of a decade we have been fighting. Mr. Rodriguez stated that it started a long time ago, March 2011, when Stan Neron was the campaign manager and Charlene Bathelus and he started running. Mr. Rodriguez stated that they used to laugh at us and tell us good luck, what are you doing this for, and there is no way you can

ever win. Mr. Rodriguez stated that they just kept at it and kept at it and it makes a difference. Mr. Rodriguez stated that it truly makes a difference to keep fighting for it and hard work does pay off. Mr. Rodriguez stated that he has been blessed to be able to move that needle forward a little bit. Mr. Rodriguez stated that what he learned is that real lasting change happens incrementally and with baby steps. Mr. Rodriguez stated that he truly understands the work that they have to do and God bless all of you for what you do. Mr. Rodriguez thanked the Board members and wished them good luck in their journey in 2019.

Mrs. Hugelmeyer stated that this is the last Board meeting for Maria Carvalho as President of the Board. Mrs. Hugelmeyer introduced a PowerPoint presentation and a video showing the highlights and accomplishments during the past year.

Mrs. Carvalho stated that she is humbled and none of that work could have been done without all of you sitting around this table. Mrs. Carvalho stated that everyone here has been a part of this, from opening the doors to closing the doors and making sure the kids are there. Mrs. Carvalho stated that everything has worked because we are finally working together. Mrs. Carvalho stated that she is honored to be here with each and every one. Mrs. Carvalho stated that she looks forward to getting her nose out of reading contracts and getting back to work next year. Mrs. Carvalho stated that Charlene Bathelus and Stanley Neron know exactly what she is saying. Mrs. Carvalho stated that it has been an amazing year and she learned a lot. Mrs. Carvalho stated that she is looking forward to stepping back and allowing the new president to do his or her job and being supportive. Mrs. Carvalho thanked the Board members, directors, staff, and especially the Superintendent.

Mr. Neron thanked Mrs. Carvalho for standing up for us, being a leader, and taking us one step further toward excellence and being a model district nationally. Mr. Neron stated that as president it is not easy to be everywhere, all at the same time, to make an impact and to continue the legacy that has been set forth. Mr. Neron thanked Mrs. Carvalho for upholding the mantle and making us proud, the district proud, and more importantly, always remembering the focus which is our children. Mr. Neron stated that it takes time from our families and we all know and understand the trials and tribulations. Mr. Neron stated that it hasn't been easy for the Board and we all have had our ups and downs and challenges this year and yet you have been able to pull us all together and keep us together. Mr. Neron thanked Mrs. Carvalho for her hard work and dedication.

Board President Carvalho presented the following public participation statement.

"At this time, the microphones are open for public comment to those who have signed in. I shall call individuals to the microphones based on the order of the sign-in. Each statement made by a participant shall be limited to three minutes in duration. The total time of public comment shall be limited to sixty minutes. No individual is able to yield their time to another individual. All statements shall be directed to the presiding officer; no participant may address or question Board members individually. The following rules for public participants shall apply: time limits will be strictly enforced, no personal attacks on individuals, no vulgar or indecent language, a person may address the Board no more than once during a single meeting, speakers should refrain from naming individuals, and comments or questions posed during public participation will not be debated. As a reminder, this is a meeting of the Board in public, not a meeting of the public."

Mrs. Carvalho called upon the first public participant, Maria Medeiros DaRassi, to address the Board.

Maria Medeiros DaRassi, 420 Fay Avenue, spoke about holding the Board members accountable, equal opportunity, and questioned why only two African Americans were hired since July.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Edith Lugo, to address the Board.

Edith Lugo, parent, stated that her son is attending an out-of-district school and spoke about the problems with the bus company.

Mrs. Hugelmeyer requested she speak with Assistant Superintendent of Teaching and Learning Jennifer Cedeno, Supervisor of Special Services Diana Pinto-Gomez, and Board member Diane Barbosa.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Patricia Gallante, to address the Board.

Patricia Gallante, 750 Grier Avenue, thanked the President for her years of service. Ms. Gallante stated that she was upset that a member of the public was asked to sit on the dais at the Board meeting held on Saturday. Ms. Gallante stated that a parent was not able to sign in to speak and she was speaking on her behalf about her daughter who needs help and that she has asked four times for an evaluation.

Mrs. Carvalho thanked her for her comments and requested the parent speak with Assistant Superintendent for Schools Rafael Cortes.

Since there were no other public participants signed in to address the Board, Mrs. Carvalho closed this portion of the meeting.

Mr. Neron excused himself from the meeting at 6:30 p.m.

Board President Maria Carvalho stated that this is an agenda setting meeting. Mrs. Carvalho stated that we will go tab by tab and each Board member may ask questions. Present for the meeting were Director of Security Matthew Glackin, Director of Food and Nutrition Services Jamie Leavitt, Director of Elementary and Secondary Education Daphne Marchetti, Director of Curriculum and Instruction Aaron Goldblatt, Acting Director of Staff Development and Innovative Programs Kathleen Badalis, Director of Plant, Property and Equipment Luis Couto, Director of Athletics Bartolomeo Candelino, Director of Bilingual and ESL Education Sandra Nunes, Director of Special Services Diana Pinto-Gomez, and Purchasing Agent Mario Rodrigues. The Board reviewed the agenda.

#### Minutes of the November 19, 2018 Agenda and Business Meetings Secretary/Treasurer's Report for the Month of October 2018

Mrs. Carvalho asked if there were any questions.

Mrs. Carvalho added the Minutes of the Meetings and the Secretary/Treasurer's Report to the agenda.

#### Personnel Report

Mrs. Carvalho asked if there were any questions.

Mrs. Hugelmeyer asked Chief of Operations Francisco Cuesta to provide a summary of the Personnel Report.

Chief of Operations Francisco Cuesta gave a synopsis of the report. Mr. Cuesta stated that there is a speaker here tonight who made a comment that from July 1<sup>st</sup> to today only two African Americans were hired. Mr. Cuesta stated that comment is totally false and totally incorrect. Mr. Cuesta stated that the fact of the matter is that not only have we hired several teachers including a math teacher and a science teacher, we have hired a supervisor, we have hired a coordinator, we have hired security guards, we have hired a guidance counselor, we have

hired a school psychologist, and that all of these positions that he just mentioned are all African Americans. Mr. Cuesta stated that we will continue to strive to do the best we can to make sure that the district reflects the great diversity that we have in this district. Mr. Cuesta stated that it is not a good idea to give misinformation and if people have a complaint or a legitimate issue that's fine but to come here and say that only two have been hired since July 1<sup>st</sup> is totally false. Mr. Cuesta stated that he hopes that clarified that matter.

Mrs. Carvalho added the Personnel Report to the agenda.

Director of Athletics Bartolomeo Candelino stated the Cal Ripken Experience is something we have been doing for the last number of years for our baseball team to go to Myrtle Beach, South Carolina for pre-season. Mr. Candelino stated that we compete against some of the better teams in the country. Mr. Candelino stated that it gives our athletes an advantage in that we get an early start when the weather in New Jersey is bad and a number of teams are doing this in New Jersey. Mr. Candelino stated that it also showcases our athletes to college coaches who attend the showcase throughout the country.

Mrs. Carvalho added the Superintendent's Report – Considerations to the agenda.

Director of Curriculum and Instruction Aaron Goldblatt stated that the Middle States Association Commission on Elementary and Secondary Schools will begin the reaccreditation process of our seven high schools beginning January 2019 through the Spring of 2020. Mr. Goldblatt stated that there is a grade on twelve different standards. Mr. Goldblatt stated that the process changed and this year we are going through as one process.

Mrs. Carvalho asked if that will help us and will all the schools participate.

Mr. Goldblatt responded yes and there is a piece by central office and each high school has a piece.

Mrs. Carvalho added the Authorizations Report to the agenda.

Mr. Couto stated that we have a contract with Honeywell for all of our schools but not School No. 14. Mr. Couto stated that this is increasing the contract by \$8,000. so that we have a contract for all of our schools.

Mrs. Moreno-Ortega asked if School No. 14 will have air conditioning.

Mr. Couto stated that School Nos. 14 and 14 Annex both have air conditioning.

Mrs. Hugelmeyer requested Director of Bilingual and ESL Education Sandra Nunes speak about the contract with the Visual Arts Center.

Director of Bilingual and ESL Education Sandra Nunes stated that this is an extension of the contract. Mrs. Nunes stated that every year our eighth grade students go to the Visual Arts Center and the trips will be starting in January.

already in discussion with a co-op. Mr. Couto stated that if that works we could probably have air conditioning in late Spring but if not, then definitely for September.

Mrs. Carvalho asked if this will be three schools all at once or is one contractor going to win the bid to do all three schools.

Mr. Couto stated that if they go with a co-op we may get one contractor to do all the schools. Mr. Couto stated that if we go with a public bid, then it depends on the bids.

Mrs. Carvalho added the above resolutions to the agenda.

Mrs. Carvalho asked if there was any new business or any comments from the Board members.

Mr. Jacobs spoke about the Saturday retreat and stated that he was happy with the progress and the teamwork that we were displaying as a team. Mr. Jacobs stated that what especially excited him was our talk of writing and creating an equity policy to deal with issues of equity amongst all of our schools and students and creating work towards diversity. Mr. Jacobs stated that the district has been improving and we are improving more on a daily basis, writing an equity policy and creating an office of equity to handle the many issues that we've seen over the years in our schools because all of our schools can be blue ribbon schools if we take an equitable approach to it. Mr. Jacobs stated that he was also happy with the communication agreements that we finally approved. Mr. Jacobs stated that was a big accomplishment. Mr. Jacobs stated that they did a lot of valuable work on Saturday with strengthening our Board and better serving our constituents.

Mr. Kennedy stated that the 2<sup>nd</sup> reading and adoption of the Domestic Violence Policy File Code No. 4111.2/4211/2 need to be added to the agenda.

Mrs. Carvalho added the 2<sup>nd</sup> reading and the Resolution for the Domestic Violence Policy to the agenda.

Mrs. Carvalho congratulated the basketball team for their first win and everyone who worked to make this happen. Mrs. Carvalho stated that the kids were happy and it was impressive to see how respectful they were, how the players came off the court and everyone stood up for each other. Mrs. Carvalho stated that she was blown away by their behavior and proud to be from Elizabeth. Mrs. Carvalho thanked Director of Athletics Bartolomeo Candelino for all of his hard work.

Director of Athletics Bartolomeo Candelino thanked the Board because this past weekend was a definite step in the right direction, not only for our basketball program but also for the City of Elizabeth. Mr. Candelino thanked the Board of Education for allowing the Hoop Group, which is a very prestigious organization in the State of New Jersey and throughout the country, to come. Mr. Candelino stated that it is an accomplishment for the Board and our basketball program moving forward to have the Hoop Group hold their showcase, their tip-off classic, for Friday, Saturday, and Sunday. Mr. Candelino thanked the Board on behalf of our athletes and the community for allowing this to happen this week and that it was a great showcase. Mr. Candelino stated that the environment showed that Saturday night at our basketball games which hasn't really been there in many years.

Mrs. Carvalho stated that the concession stand was open and thanked Director of Nutrition and Food Services Jamie Leavitt for hearing their cries. Mrs. Carvalho stated that people were lined up and they couldn't get their food fast enough. Mrs. Carvalho stated that there is always room for improvement and we are in a better place than we were before. Mrs. Carvalho stated that the staff was amazing and they did what they could and didn't expect to see as many



people as they did. Mrs. Carvalho stated that the crowd is only going to get bigger and our concession stand is only going to get better as long as we work together to make it happen.

Mrs. Carvalho wished everyone a happy holiday and stated that in her home they celebrate Christmas and wished everyone a Merry Christmas. Mrs. Carvalho thanked the directors for all of their work and patience with her this year. Mrs. Carvalho stated that she is not easy especially when she wants something done. Mrs. Carvalho stated that next year she will continue to work as hard as she did this year if not even harder because she won't have as much on her plate to read every night. Mrs. Carvalho stated that they will continue to work for the children of Elizabeth.
