BOARD OF EDUCATION (Official)

February 21, 2019 Elizabeth, New Jersey

The regular business meeting of the Board of Education was called on February 21, 2019 at 6:30 p.m. at Thomas A. Edison Career and Technical 9th Grade @ Charles Harris Academy, 425 Grier Avenue, Elizabeth, New Jersey.

Board President Stephanie Goncalves presented the following statement at 6:50 p.m.

"Ladies and Gentlemen, good evening. This is a regular business meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth on February 15, 2019. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth, New Jersey.

"We want to welcome everyone present and our television viewers to this meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public.

"This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. We also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, we may have to ask for order periodically should noise begin to interfere with our recording capabilities. We are pleased that you have taken time to join us here for our Board of Education meeting. Thank you for your interest in the Elizabeth Public Schools."

"There will be a public portion for citizens to address the Board. Participants for the public portion may sign in up to the start of the public speaking so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Miss Goncalves introduced a video presentation of the Core Beliefs.

Miss Goncalves introduced Adriana Pacius, ninth grade student at Thomas A. Edison Career and Technical 9th Grade @ Charles Harris Academy who recited the poem, *Still I Rise* by Maya Angelou. Miss Goncalves thanked Adriana for the wonderful performance.

Miss Goncalves introduced Joselyn Gracia, ninth grade student at Thomas A. Edison Career and Technical 9th Grade @ Charles Harris Academy who recited the poem, *Phenomenal Women* by Maya Angelou. Miss Goncalves thanked Joselyn for the wonderful performance.

Miss Goncalves introduced students from The Liberty Players at Thomas Jefferson Arts Academy including Cooper Mendonssa, Ariana Montoya, Angela Ocampo, Celina DaSilva, Jayleen Ojeda, and Diana Benenaula who performed an Evita medley, *Oh What a Circus/Don't Cry for Me Argentina*, music by Andrew Lloyd Webber and lyrics by Tim Rice. Miss Goncalves thanked them for a wonderful performance.

Miss Goncalves introduced a presentation of *African History – Greatness in America and Throughout the World* in honor of Black History Month. Miss Goncalves introduced Kwao Taylor, physical education and health teacher at Jerome Dunn Academy, who was the emcee for the performances.

Mr. Kwao Taylor thanked everyone for coming and stated that before he begins it is customary in all African celebrations to ask his elders if it is okay for him to proceed and speak. Mr. Taylor thanked his elders and stated that tonight they will start in Africa, specifically in Egypt that was originally called Kemet, or the Land of the Black, and was the first to have a written language called Mdju Netjer, later called hieroglyphics. Mr. Taylor stated that it is called the Cradle of Civilization.

Mr. Taylor introduced Imhotep portrayed by Angel Pulinario, student at Jerome Dunn Academy School No. 9; African Dance by students from George Washington Academy School No. 1 and Jerome Dunn Academy School No. 9; Pan Africa by Erna Letemps, fifth grade teacher at Nicholas M. Butler School No. 23: African Slave Ship Dance by students from Nicholas Murray Butler School No. 23; Glory performed by students from Nicholas Murray Butler School No. 23; Toussaint L'Ouverture portrayed by Emmanuel Morales, student at Jerome Dunn Academy School No. 9; video presentation of Dr. Martin Luther King, Jr. and Malcom X; Debate of Malcolm X and Dr. Martin Luther King, Jr., by Patrick Robinson and Francis Boakye students at Jerome Dunn Academy School No. 9; Michelle Obama and Barack Obama portrayed by Raysonna Johnson, student at George Washington Academy School No. 1 and Harvey Tejada, student at Jerome Dunn Academy School No. 9; African Attire Fashion Show by students from George Washington Academy School No. 1 and Jerome Dunn Academy School No. 9; and The Sermonette by Brenda Griggs, child development associate at Mabel G. Holmes Annex School No. 5. Mr. Kwao Taylor congratulated all the students involved in the performances and invited them to come forward. Miss Goncalves invited the teachers and administrators who helped with this performance to join them. Miss Goncalves and Board members congratulated them for a wonderful performance.

Mrs. Hernandez recognized the student government at Thomas A. Edison Career and Technical Academy including advisor Samantha Bernardi, president Carolin Villafana, vice

Mr. Neron and Board members congratulated them and presented each with a certificate of commemoration.

Mrs. Barbosa recognized Joseph Kupetz for his donation of more than 10,000 books to the EHS-Frank J. Cicarell Academy. Mrs. Barbosa and Board members thanked him for his generosity. Mrs. Barbosa stated that Mr. Kupetz was ill and unable to attend. Principal Michael Cummings accepted the certificate of commemoration on behalf of Joseph Kupetz.

Miss Goncalves stated that she has designated office hours every Monday night from 5:30 p.m. to 7:00 p.m. during which Elizabeth families may make an appointment to meet with her and discuss any issues or concerns pertaining to the Elizabeth Public Schools. Miss Goncalves stated that she has visited several of our schools on her President's *One of Kind* Tour. Miss Goncalves stated that with this month being the celebration of Black History Month she saw many great displays honoring the contributions of African-Americans to the Elizabeth community, the State of New Jersey, our nation, and the world.

Miss Goncalves recognized the recent loss of one of those great contributors as Elizabeth lost one of its own, Don Newcombe. Miss Goncalves stated that Brooklyn and Los Angeles Dodgers great Don Newcombe grew up here in Elizabeth and attended Thomas Jefferson High School. Miss Goncalves stated that Don Newcombe played for the first racially integrated baseball team based in the United States in the 20th century, the 1946 Nashua Dodgers of the New England League before becoming the third African-American pitcher in the major leagues in 1949 when he joined the Brooklyn Dodgers, a season for which he won National League Rookie of the Year. Miss Goncalves stated that Don Newcombe was a four-time All-Star who won the 1956 National League MVP Award and was the first ever recipient of the Cy Young Award in 1956, then given to the best pitcher in the combined major leagues. Miss Goncalves stated that Don Newcombe also served two years in the Korean War in the middle of his playing career and eventually returned to the Dodgers organization after retirement as a player to serve as the Director of Community Affairs.

Miss Goncalves stated that she would like everyone to applaud our students who entertained and educated us this evening about several prominent African-Americans who helped change our society for the better. Miss Goncalves stated that diversity is such an empowering quality that we possess in our schools and in this vibrant City. Miss Goncalves stated that it is so important that we take these opportunities to showcase the various cultures within our community that make us so unique and special.

Miss Goncalves stated that the Board is presenting a resolution tonight to remove the name from School No. 25.

Miss Goncalves stated that an Ad Hoc Committee for School Safety and Security be in effect from this date and shall terminate as of the Reorganization Meeting 2020.

A motion was made by Ms. Bathelus, seconded by Mrs. Moreno-Ortega for the creation of an Ad Hoc Committee for School Safety and Security.

Miss Goncalves stated that Mrs. Barbosa, Mrs. Carvalho, and Mr. Jacobs will be on the Ad Hoc Committee for School Safety and Security.

Board President Stephanie Goncalves presented the following public participation statement.

"At this time, the microphones are open for public comment to those who have signed in. I shall call individuals to the microphones based on the order of the sign-in. Each statement made by a participant shall be limited to three minutes in duration. The total time of public comment shall be limited to sixty minutes. No individual is able to yield their time to another individual. All statements shall be directed to the presiding officer; no participant may address or question Board members individually. The following rules for public participants shall apply: time limits will be strictly enforced, no personal attacks on individuals, no vulgar or indecent language, a person may address the Board no more than once during a single meeting, speakers should refrain from naming individuals, and comments or questions posed during public participation will not be debated. As a reminder, this is a meeting of the Board in public, not a meeting of the public."

Miss Goncalves called upon the first public participant, Salaam Ismial, to address the Board.

Salaam Ismial, 14 Denman Place, National United Youth Council, spoke about Black History Month, the Amistad curriculum, that this building was not formally named Charles Harris, and that he is here for the African-American children and community.

Miss Goncalves thanked him for his comments and called upon the next public participant, Maria Lorenz, to address the Board.

Maria Lorenz, 103 Murray Street, spoke about SEPAC and that she was offended that a vulgar word was used at a SEPAC meeting.

Miss Goncalves thanked her for her comments and called upon the next public participant, Christina Moreira, to address the Board.

Christina Moreira, 805 Gebhardt Avenue, asked for notifications about SEPAC be sent to parents with children who have a 504. Mrs. Moreira spoke about African-American studies and stated that the high school websites have no information about electives and the high school tours in April are a little late to get information.

Miss Goncalves thanked her for her comments and called upon the next public participant, Patricia Gallante, to address the Board.

Patricia Gallante, 750 Grier Avenue, stated that there is no name on this building and it is not recognized as Charles Harris Academy. Ms. Gallante stated that Shade Lee was a proud Tuskegee Airman who was from Elizabeth. Ms. Gallante stated that the policy for naming a school is important and should involve the community. Ms. Gallante asked about the solar panels on the buildings.

Miss Goncalves thanked her for her comments.

Mrs. Hugelmeyer stated that the solar panel project is currently being worked on. Mrs. Hugelmeyer stated that the high schools brochure goes out in the beginning of the year and there are several information sessions set up.

Reverend George Britt, 160 Madison Avenue, thanked the students for the performances for the history of Africa. Rev. Britt spoke about the Amistad law to implement into the curriculum.

Miss Goncalves thanked him for his comments.

Mrs. Hugelmeyer stated that a two-hour presentation was made at the board meeting last week of Amistad. Mrs. Hugelmeyer stated that the Amistad presentation will be on our website.

Since there were no public participants signed in to address the Board, Miss Goncalves closed this portion of the meeting.

Board President Stephanie Goncalves requested a motion to go into Private Session to consider matters exempt under the Open Public Meetings Act, specifically for discussion of legal matters, specifically, settlement agreements A.O., S.A., termination - A.S., interview, ratification of name change. The board will reconvene in public and may take formal action.
