BOARD OF EDUCATION (Official)

April 13, 2017 Elizabeth, New Jersey

The regular meeting of the Board of Education was called on April 13, 2017 at 6:30 p.m., at Juan Pablo Duarte-José Julián Martí School No. 28, 25 First Street, Elizabeth, New Jersey.

Board President Stanley Neron presented the following statement at 6:42 p.m.

"Ladies and Gentlemen, good evening. This is a regularly scheduled program and meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth on Tuesday, April 11, 2017. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth, New Jersey."

"We want to welcome everyone present here at Juan Pablo Duarte-José Julián Martí School No. 28 and to our television viewers to this April 13, 2017 meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public."

"This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. We also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, we may have to ask for order periodically should noise begin to interfere with our recording capabilities. We are pleased that you have taken time this evening to join us here for our Board of Education meeting. Thank you for your interest in the Elizabeth Public Schools."

"There will be a public portion for citizens to address the Board. Participants for this public portion must sign in up to the start of public speaking so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Mr. Neron stated that a young man, Michael Eargle, EHS Class of 2007, tragically left us too soon because of a senseless act of violence. Mr. Neron called for a moment of silence to remember Michael Eargle and reflect upon how we can help our community to heal and rise above the violence that continues to rob communities throughout this nation of their youth, their promise, and their future.

The *Star Spangled Banner* by Francis Scott Key was performed by trumpeter Nichole Toro-Guerrero, seventh grade student at Juan Pablo Duarte-Jose Julian Marti School No. 28.

Pledge of Ethics

Mr. Neron welcomed everyone to School No. 28 and stated that April is Autism Awareness Month. Mr. Neron stated that in honor of Autism Awareness Month schools and administrative offices throughout our district have installed a blue light at the entry of the buildings in support of our families who have been affected by autism. Mr. Neron stated that Board member Diane Barbosa visited students in the autism program this past Tuesday as part of Visiting Tuesdays initiative. Mr. Neron stated that it is important that we show our support for these families as well as all the families of our students with special needs. Mr. Neron stated that the Elizabeth Public Schools promise is to ensure that every child achieves excellence and we are here to make certain that all students in our school system receive a high quality education. Mr. Neron introduced a video presentation of Autism Awareness.

Supervisor of Music Dennis Argul thanked the Board for the recognition and the music teachers for their excellence in music education.

Mr. Rodriguez stated that the City of Elizabeth is issuing Elizabeth Municipal Identification Cards at the Elizabeth Public Library.

Board President Neron presented the following public participation statement.

"At this time, the microphones are open for public comment to those who have signed in. I shall call individuals to the microphones based on the order of the sign-in. Each statement made by a participant shall be limited to three minutes in duration. The total time of public comment shall be limited to sixty minutes. No individual is able to yield their time to another individual. All statements shall be directed to the presiding officer; no participant may address or question Board members individually. The following rules for public participants shall apply: time limits will be strictly enforced, no personal attacks on individuals, no vulgar or indecent language, a person may address the Board no more than once during a single meeting, speakers should refrain from naming individuals, and comments or questions posed during public participation will not be debated. As a reminder, this is a meeting of the Board in public, not a meeting of the public."

Mr. Neron called upon the first public participant, Christina Moreira, to address the Board.

Christina Moreira, 805 Gebhardt Avenue, stated that there is not a written policy on medical bills for students hurt on a bus. Mrs. Moreira spoke about the recent murder of a young man in the City, the doctrine of necessity, agendas not being posted, the Board voting on the whole agenda instead of individual items, and Pat Politano's inaccurate statement regarding public input for naming of the school. Mrs. Moreira stated that this is not the change we asked for from the new Board.

Mr. Neron thanked her for her comments and called upon the next public participant, Maria Lorenz, to address the Board.

Maria Lorenz, 103 Murray Street, spoke about a missing child, ethics charges against four Board members, the inaccurate information in Pat Politano's statement about public input for naming the school, and stated that the Board should be focusing on the non-performing schools.

Mr. Neron thanked her for her comments and called upon the next public participant, Kason Little, to address the Board.

Kason Little, student, spoke about the inaccurate article by Pat Politano that there was no public input in naming the school and asked the Board if students are the first priority.

Mr. Neron thanked him for his comments and called upon the next public participant, Salaam Ismail, to address the Board.

Salaam Ismial, 513 Richmond Street, United Youth Council, stated that when kids speak you should stop and listen. Mr. Ismial stated that two years ago he presented gun violence awareness to the Board and it fell on deaf ears and now one of our own, Michael Eargle, was killed by gun violence. Mr. Ismail spoke about the curriculum of inclusion and asked the Board to look at this area. Mr. Ismial spoke about the Youth March on the Capitol in Trenton on April 22nd and asked the Board members for help but has heard nothing.

Mr. Neron thanked him for his comments and called upon the next public participant, Rev. Joe Adair, to address the Board.

Rev. Joe Adair, Second Macedonia Baptist Church, stated that he is the President of the NAACP and has seven children who graduated from the Elizabeth Public Schools and has seven grandchildren in the district. Rev. Adair spoke about the need for the curriculum of inclusion and that the Board should consider naming a school after educator Charles Harris. Rev. Adair spoke about the senseless murder of Michael Eargle.

Mr. Neron thanked him for his comments. Since there were no other public participants signed in to address the Board, Mr. Neron closed this portion of the meeting.

Mr. Perreira stated that this is the second time he has heard about the comments for naming the school. Mr. Perreira stated that this can be an issue for the students and the community. Mr. Perreira stated that perhaps we can put together a link on the website for suggestions and then choose three names for the students and community to vote.
