## BOARD OF EDUCATION (Official)

May 10, 2018 Elizabeth, New Jersey

The regular business meeting of the Board of Education was called on May 10, 2018 at 6:30 p.m., at Juan Pablo Duarte-José Julián Martí School No. 28, 25 First Street, Elizabeth, New Jersey.

Board President Maria Carvalho presented the following statement at 6:45 p.m.

"Ladies and Gentlemen, good evening. This is a regular business meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth, New Jersey.

"We want to welcome everyone present and our television viewers to this May 10, 2018 meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public.

"This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. We also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, we may have to ask for order periodically should noise begin to interfere with our recording capabilities. We are pleased that you have taken time this evening to join us here for our Board of Education meeting. Thank you for your interest in the Elizabeth Public Schools."

"There will be a public portion for citizens to address the Board. Participants for the public portion may sign in up to the start of the meeting so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Mrs. Carvalho stated that tonight we are celebrating Juan Pablo Duarte-José Julián Martí School No. 28 for exiting Focus School status. Mrs. Carvalho introduced Principal of Juan Pablo Duarte-José Julián Martí School No. 28 Evelyn Rodriguez-Salcedo to share the journey of achieving this success.

Mr. Rodriguez excused himself from the meeting at 9:00 p.m.

Principal Evelyn Rodriguez-Salcedo stated that tonight is a night to celebrate that Juan Pablo Duarte-José Julián Martí School No. 28 is out of Focus School status. Mrs. Rodriguez-Salcedo stated that the big question is "What was attributed to School No. 28's big success?" Mrs. Rodriguez-Salcedo stated that they partnered with the New Jersey Department of Education and set Smart Goals in language arts performance, mathematics performance, chronic absenteeism, and social emotional learning. Mrs. Rodriguez-Salcedo stated that School No. 28 met the criteria to exit Focus status with a score of 30.4, which is well above the combined total number required to exit as a School in Need of Improvement. Mrs. Rodriguez-Salcedo stated that the English language learners and the special education students are the two sub-groups that needed to make improvements. Mrs. Rodriguez-Salcedo explained a PowerPoint slide showing the overall three-year PARCC performance improvement from 2015 to 2017 that the English language learners and the special education students made in language arts and mathematics. Mrs. Rodriguez-Salcedo stated that when asked what the best thing is about School No. 28, the students said that the teachers care about them. Mrs. Rodriguez stated that they teachers give 110% and sacrifice their personal time to be here before school, during lunch, and after school to help the students achieve at high levels. Mrs. Rodriguez-Salcedo stated that they work many hours preparing lessons, correcting papers, giving feedback, and answering concerns of students and parents. Mrs. Rodriguez-Salcedo stated that they are always looking for new programs, new partnerships, new ideas, and things to do with our students to make sure that they are helping them not only academically but also socially. Mrs. Rodriguez-Salcedo thanked the staff members and support staff for all their dedication and stated that they are the main reason why this was achieved. Mrs. Rodriguez-Salcedo thanked the students and parents for all their work and their desire to learn and succeed. Mrs. Rodriguez-Salcedo stated that the factors that attributed to their success included interventions such as before school tutoring program, period 1 whole school intervention, lunch tutoring, EdConnect assessments, data driven individualized instruction, after school character education program, bilingual intensification after school for math and language arts, and the district enrichment and art after school program. Mrs. Rodriguez-Salcedo stated that to establish a culture of data analysis and data driven instruction they analyzed the PARCC data by grade level performance and scale scores in language arts and mathematics to create a baseline for student achievement. Mrs. Rodriguez-Salcedo stated that using the benchmark data they awarded superstar to classes that exceed the district average on each marking period's benchmark. Mrs. Rodriguez-Salcedo stated that each student created a personal data binder in every classroom to track their personal data including tests, benchmark scores, and DRA reading levels. Mrs. Rodriguez-Salcedo stated that students analyze and determine their personal learning styles and use this information to make everyday choices while teachers use this data to drive their instruction. Mrs. Rodriguez-Salcedo stated that they have parent involvement and workshops including ESL classes for parents, HIB law workshop, bullying and internet, PowerSchool tutorial, positive discipline practices, raising successful children and how you can help your child succeed at school. Mrs. Rodriguez-Salcedo stated the accomplishments include being a National School of Character, New Jersey School of Character, National Junior Honor Society, Junior Achievement, New Jersey Safe Routes to School, Let's Move Active Schools, AVID, Special Olympics Project Unify, Positive Behavior Support in Schools, Healthy U, HISPA, and Green Flag Award. Mrs. Rodriguez-Salcedo stated that our success will not stop here and we will set achievable goals that will lead to higher accomplishments. Mrs. Rodriguez-Salcedo thanked everyone for everything they do for the students at Juan Pablo Duarte-José Julián Martí School No. 28.

Juan Pablo Duarte-José Julián Martí School No. 28 PTO President thanked Mrs. Rodriguez-Salcedo and the amazing staff at School No. 28.

Mrs. Carvalho thanked Mrs. Rodriguez-Salcedo, staff members, parents, and students on their success. Mrs. Carvalho stated that the Board members are here if you need anything to make sure that School No. 28 continues to be the best and continues to succeed.

Mrs. Moreno-Ortega thanked the staff members and congratulated them. Mrs. Moreno-Ortega stated that she is very proud of School No. 28.

Board President Carvalho presented the following public participation statement.

"At this time, the microphones are open for public comment to those who have signed in. I shall call individuals to the microphones based on the order of the sign-in. Each statement made by a participant shall be limited to three minutes in duration. The total time of public comment shall be limited to sixty minutes. No individual is able to yield their time to another individual. All statements shall be directed to the presiding officer; no participant may address or question Board members individually. The following rules for public participants shall apply: time limits will be strictly enforced, no personal attacks on individuals, no vulgar or indecent language, a person may address the Board no more than once during a single meeting, speakers should refrain from naming individuals, and comments or questions posed during public participation will not be debated. As a reminder, this is a meeting of the Board in public, not a meeting of the public."

Mrs. Carvalho called upon the first public participant, Maria Lorenz, to address the Board.

Maria Lorenz, 103 Murray Street, spoke about the SEPAC Resource Fair and asked why the Education Law Center was not invited to the fair.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Christina Moreira, to address the Board.

Christina Moreira, 805 Gebhardt Avenue, acknowledged the teachers and nurses. Mrs. Moreira spoke about the increase in school lunch prices.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Danielle Fienberg, to address the Board.

Danielle Fienberg, 631 North Broad Street, spoke about the gifted and talented process for second through eighth grade students.

Mrs. Carvalho thanked her for her comments. Since there were no other public participants signed in to address the Board, Mrs. Carvalho closed this portion of the meeting.

Superintendent Hugelmeyer stated that the food service average price increase is twenty cents. Mrs. Hugelmeyer explained that the difference in price for the high school is the salad bar.

Ms. Bathelus asked who is on the committee.

Mr. Kennedy stated that there was a difference in price between the elementary lunch for \$2.80 and the middle school lunch for \$3.10 and that effective January 1 all K-8 lunch prices are \$2.80 for this year. Mr. Kennedy stated that the prices for July 1 show that the a la carte pricing was made uniform throughout the district.

Ms. Bathelus stated that she remembers the conversation about the pricing through June 30<sup>th</sup> but doesn't recall coming up with these new prices and if Director Jamie Leavitt said she was going to bring it back to us to discuss prior to setting it in the agenda.

## Minutes of the Meetings of April 10 and 19, 2018
