Prior to the scheduled reorganization and regular meeting of the Elizabeth Board of Education at 7:30 p.m. held in the Multi Purpose Room, Donald Stewart Center for Early Childhood Education, 544 Pennsylvania Avenue, Elizabeth, New Jersey, Assistant Board Secretary Donald Gonçalves welcomed all to the meeting.

Colors were presented during the Flag Ceremony by members of the Admiral William F. Halsey, Jr. Leadership Academy Marine Corps Junior R.O.T.C., followed by the Pledge of Allegiance led by Jordy Hernandez, eighth grade student at William F. Halloran School No. 22 @ 31. The *Star-Spangled Banner* by Francis Scott Key was performed by Naomi Chavanne, senior at Thomas Jefferson Arts Academy.

Dr. William Greene gave the invocation.

The Pledge of Ethics was led by Jordy Hernandez, eighth grade student at William F. Halloran School No. 22 @ 31.

Assistant Board Secretary Donald Gonçalves introduced a video presentation of the Core Beliefs and Commitments.

The members of the Board of Education met for the purpose of reorganization and a regular meeting on Thursday, May 12, 2011 held in the Multi Purpose Room, Donald Stewart Center for Early Childhood Education, 544 Pennsylvania Avenue, Elizabeth, New Jersey.

School Business Administrator/Board Secretary Harold E. Kennedy, Jr. presented the following statement at 8:20 p.m.

"Ladies and Gentlemen, good evening. This is the annual reorganization meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth on Monday, May 9, 2011. In addition, this notice is posted on the bulletin board in the lobby of the Mitchell Building, 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth.

There will be a public portion for citizens to address the Board. Participants for the public portion must sign in one hour prior to the advertised start of the meeting so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Mr. Nelson stated that the Education Act requires that at the organization meeting the Board shall elect from its members a President and a Vice President who shall serve for terms of one year. Nominations will be made from among the membership of the Board present. Elections shall be by the majority of the vote present and voting which means this is the majority of the quorum. When nominations are made they do not require a second, however, in order to close nominations there must be a motion to second and then a vote to close nominations for the office of President or Vice President. To conduct the election for President and Vice President, there will be the election of a President Pro Tem, and the same rules will apply for the voting process in that regard and the election of the President Pro Tem will be conducted by the Board Secretary. President Pro Tem is elected solely for conducting the election of a President.
