BOARD OF EDUCATION (Official)

May 12, 2015 Elizabeth, New Jersey

The regular meeting of the Board of Education was called on May 12, 2015 at 7:00 p.m., in the MultiPurpose Room, Donald Stewart Center for Early Childhood Education, 544 Pennsylvania Avenue, Elizabeth, New Jersey.

Board President Ana Maria Amin presented the following statement at 7:45 p.m.

"Ladies and Gentlemen, good evening. This is a regularly scheduled meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to Worrall Community Newspapers, The Star Ledger and Cablevision of Elizabeth on Friday, May 8, 2015. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth."

"I wish to extend a warm welcome to everyone present and to our television viewers to this May 12, 2015 meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public."

"This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. I also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, I may have to ask for order periodically should noise begin to interfere with our recording capabilities. I am pleased that you have taken time this evening to join us. Thank you for your interest in the Elizabeth Public Schools."

"There will be a public portion for citizens to address the Board. Participants for the public portion must sign in one hour prior to the advertised start of the meeting so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Superintendent of Schools Olga Hugelmeyer, School Business Administrator/Board Secretary Harold E. Dr. William Greene gave the invocation.

Colors were presented during the Flag Ceremony by members of the Admiral William F. Halsey, Jr. Leadership Academy Marine Corps Junior R.O.T.C. followed by the Pledge of Allegiance led by eighth grade student Jessica Quinte, and seventh grade students Bruna DeSouza, Gabriela Duran, and Valeria Morales from Juan Pablo Duarte-José Julián Martí School No. 28.

The *Star Spangled Banner* by Francis Scott Key was performed by students from Juan Pablo Duarte-José Julián Martí School No. 28.

The Pledge of Ethics was led by eighth grade student Jessica Quinte, and seventh grade students Bruna DeSouza, Gabriela Duran, and Valeria Morales from Juan Pablo Duarte-José Julián Martí School No. 28.

Mrs. Amin introduced a video presentation of the Core Beliefs and Commitments.

Mrs. Amin introduced kindergarten students from Juan Pablo Duarte-José Julián Martí School No. 28 who performed a dance to *Mambo No*. 8 by Perez Prado. Mrs. Amin thanked the students for the wonderful performance.

Mr. Perreira recognized Adáo Pinto, Consul General of the Republic of Angola, for his commitment, dedication and contribution to excellence in education as a means to foster economic and financial growth for Angolans working to achieve the American dream this country has to offer.

The National Anthem of Angola was played.

Mr. Perreira introduced Adáo Pinto, Consulate of Angola, and thanked him for his work and the wonderful partnership between Angola and the Elizabeth Board of Education. Mr. Perreira and Board members presented a plaque of commemoration to Adáo Pinto.

Mr. Perreira also thanked Dr. Joao Camacho for making this possible. Mr. Perreira stated that Dr. Camacho is always looking for ways to enrich our school system and making us known around the world.

Consulate of Angola Adáo Pinto thanked the Board for the honor and stated that when we are invited to say something at an institution like this we cannot forget the word education. Mr. Pinto stated that the word education comes from the Latin word, educatus, which means help somebody grow. Mr. Pinto stated that he is here to grow and he is here to learn like those children learned to dance. Mr. Pinto stated that as Consul General he hopes to set up a relationship with this institution through cooperation.

Mr. Monteiro introduced community leaders including Grand Marshall of the Parade Leonel Cardoso, President of the Portugal Day Festivities Carla Rodriguez, Union County Freeholder Sergio Granados, former Board President Armando DaSilva, EEA Vice President and Past Grand Marshall Joseph Cortico, Interim Assistant Superintendent for Teaching and Learning Jennifer Cedeno, teachers, staff members, and everyone of Portuguese descent. Mr. Monteiro recognized the Founder of the Portugal Day Parade that started many, many years ago in the City of Elizabeth by a young man who wrote a letter to then Mayor Tom Dunn and started the process of having a parade here in the City of Elizabeth recognizing all the sacrifices and contributions of the Portuguese community and introduced Assistant Board Secretary Donald Goncalves.

The National Anthem of Portugal was played.

Mr. Monteiro stated that it is all of the hard work, time and dedication of the volunteers who sacrifice so much time that goes into making the Portugal Day a reality. Mr. Monteiro stated that it is one of the largest parades and most magnificent parades the City of Elizabeth has. Mr. Monteiro stated that the Portugal Day Parade is being held on Sunday, June 7th at 2:00 p.m. and invited everyone to attend.

President of the Portugal Day Festivities Carla Rodriguez thanked the Board of Education for recognizing the Portuguese culture and their traditions and hopes to see everyone on June 7th on Elizabeth Avenue as we show you our culture and traditions through our parade and festivities.

Carla Rodriguez thanked Maria Carvalho, who is one of us, and the Board of Education for their dedication to the kids and the community.

Resolution – Portugal Day

Mr. Monteiro read the resolution.

Mr. Trujillo thanked the students and staff from Juan Pablo Duarte-José Julián Martí School No. 28 for being here and performing tonight.

Mr. Trujillo stated that the Cubans who are left here in the City of Elizabeth and at one time they were many in numbers but now they are dwindling have a great opportunity to celebrate our culture as well. Mr. Trujillo stated that we do have our parade to celebrate our independence and putting together a parade is a lot of work and it takes some really dedicated people. Mr. Trujillo stated that people from throughout the State come and visit and celebrate with us. Mr. Trujillo introduced a few people who are responsible for the parade and deserve recognition including Director of Plant, Property, and Equipment Luis Couto, Coordinator of Security Gonzalo Quesada, Chief Information Officer of Technology Alberto Marsal, and Assistant Director of Plant, Property and Equipment Luis Milanes. Mr. Trujillo stated that this year the Grand Marshall of the Cuban Day Parade is our Superintendent of Schools Olga Hugelmeyer.

Mr. Neron stated that Board member Charlene Bathelus, who could not be with us this evening, is the 2015 Grand Marshall of the statewide Haitian Flag Day Parade. Mr. Neron introduced Bithja Lerine, representative of the New Jersey Haitian Flag Day Planning Committee and the members of the committee present including Woody Phillipe and Martel Garvil. Mr. Neron recognized all in attendance of Haitian descent including Vice Principal Wilnes Jilus, Vice Principal Donald Dulorie, and members of Jefferson Park Ministries which was founded by Catherine Santillien. Mr. Neron invited James Carey to come forward for all the work he has done for Haitian the Haitian community. Mr. Neron read a resolution in recognition of the Haitian community.

Ms. Bithja Lerine, representative of the Haitian Flag Day Planning Committee, thanked the Board of Education for recognizing the Haitian people in this great City and thanked the committee members for all their hard work. Ms. Lerine thanked the people of the City of Elizabeth for welcoming the Haitian people and letting us live among you. Ms. Lerine invited everyone to the Haitian Flag Raising Ceremony on Monday, May 18, 2015 at 4:00 p.m. at City Hall.

The National Anthem of Haiti was played.

Mr. Perreira stated that Elizabeth is truly a melting pot with many nations calling Elizabeth home and there are many more countries that we haven't recognized tonight that also call Elizabeth and the United States home. Mr. Perreira stated that it is good for our children to be able to witness this and learn from all these different cultures every day.

Mr. Perreira stated that every year students from the Elizabeth Public Schools are nominated to be recognized by the State Board of Education for their outstanding contributions to their school, community, or family. Mr. Perreira recognized Janiyah Fullwood, Mabel G. Holmes School No. 5, who was selected as the recipient of the 2015 State Board Student Recognition. Mr. Neron and Board members congratulated the students and presented each with a certificate of commemoration.

Mrs. Castillo-Ospina stated that every year the Union County Bar Association holds a contest for students to commemorate Law Day and the creation of the Magna Carta, which is the cornerstone document upon which democracy is built and which established the principal of rule of law. Mrs. Castillo-Ospina and Board members congratulated the students and teacher and presented each with a certificate of commemoration.

Mr. Rodriguez congratulated the kindergarten students for their performance tonight.

Mr. Rodriguez recognized Ms. Miranda Hanafy, fifth grade teacher at Toussaint L'Ouverture-Marquis de Lafayette School No. 6 who has been invited by the Bill and Melinda Gates Foundation to attend Elevating and Celebrating Effective Teaching and Teachers Conference in Seattle, Washington. Mr. Rodriguez stated that the conference serves to promote

collaboration, creativity, and excellence through the recognition, selection, and participation of outstanding educators in seminars, conferences and continuing education opportunities. Mr. Rodriguez and Board members congratulated Ms. Miranda Hanafy and presented her with a plaque of commemoration.

Mrs. Castillo-Ospina recognized the school nurses for their quality of care, compassion, and commitment in their practice and professionalism. Mrs. Castillo-Ospina stated that they are the ones who take care of our children if they don't feel well or need to take medication and they make sure the children have all the requirements to attend school. Mrs. Castillo-Ospina stated that they would like to recognize all of the school nurses and introduced those present including school nurses Alicia Aleman, Frances C. Smith Center for Early Childhood Education; Madeline Kelly, Frances C. Smith Center for Early Childhood Education; Ruth Perez, Dr. Antonia Pantoja School No. 27, and Nanette Sayani, William F. Mrs. Hugelmeyer stated that she has such fond memories of having either worked with them or having learned from them. Mrs. Hugelmeyer thanked each teacher individually and stated that she worked with Mrs. Aiello with the Disaffected Youth Grant many years ago; she had the pleasure of learning a great deal from Mrs. Conte-Markowitz who provides a tremendous service to our children at George Washington School No. 1; she currently works with Mrs. Fodera who is a bilingual instructional coach at central office; she had the pleasure of learning a great deal from Mrs. Fox who continues to provide our children with valuable experiences; she taught with Mrs. Kenely at Nicholas S. LaCorte-Peterstown School No. 3 where tremendous best practices were shared; she learned a great deal from Ms. Peskus who was a former science teacher trainer and trained all of our teachers on the FOSS instructional program; the tremendous impact that Mr. Saunders has on all of us and thanked him for everything that he has given to our children and our teachers; she taught with Mrs. Volikas at Nicholas S. LaCorte-Peterstown School No. 3 who introduced her to the Whole School Reform Success for All Model; and she learned a great deal from Mrs. Walsh who has touched the lives of so many children and so many of our teachers. Mrs. Hugelmeyer thanked them for what they have given, for their legacy, and for what they continue to give each and every day. Mrs. Hugelmeyer stated that it is an honor to have such dedicated teachers in the Elizabeth Public Schools, Mrs. Hugelmeyer, Mr. Monteiro, and Board members congratulated them and presented each with a certificate of commemoration.

Superintendent of Schools Olga Hugelmeyer stated that in January our Board President approached her and her staff and expressed wanting to ensure that we design the appropriate criteria to be able to recognize our parents and the important work that the parents do in our schools. Mrs. Hugelmeyer stated that through a collaborative process we designed the Most Valuable Parents (MVP) Award. Mrs. Hugelmeyer stated that this month we are publicly honoring Elizabeth Public Schools' Most Valuable Parents (MVPs) whose actions, including contributions to the school community, symbolize the finest traditions of parenting. Mrs. Hugelmeyer stated our guidance counselors provide a tremendous impact in helping children

achieve school success and plan for a career but they cannot do this alone. Mrs. Hugelmeyer stated that it is a partnership with our counselors and social workers working collaboratively with our parents.

Mrs. Hugelmeyer stated that as a result of our Board President in coordination with our guidance counselors we are proud to make the announcement of this prestigious recognition to highlight the effort of our successful parents. Mrs. Hugelmeyer stated that the nomination criteria includes that the individual must be a parent, natural, adoptive, foster, guardian, or step-parent and their child has to have demonstrated progress in their performance; students must demonstrate 95% attendance rate (with the exception of unexcused absences); parents/guardians are active members of the PTA/PTO; parents/guardians attend Parent Teacher Conferences; parents/guardians attend District Information Sessions, for example Parent Academy, Parent Seminars, College Fair; and parents/guardians volunteer/participate in school events such as Read Across America, fundraisers, serve as chaperones, etc. Mrs. Hugelmeyer stated that parents selected would have to meet four of the six criteria items.

Mrs. Amin stated that the Most Valuable Parent Award for Admiral William F. Halsey, Jr., Leadership Academy is Crissy Lockhart, and Mr. and Mrs. Michael Downey. Mrs. Amin and Board members congratulated them and presented each with a plaque of commemoration.

Mr. Rodriguez recognized former Board member Oneida Duran who was in attendance.

Mr. Neron excused himself from the meeting at 9:14 p.m.

Board President Amin presented the following public participation statement.

"At this time, the microphones are open for public comment to those who have signed in prior to this session. I shall call individuals to the microphones based on the order of the sign-in. Each statement made by a participant shall be limited to three minutes in duration. The total time of public comment shall be limited to sixty minutes. No individual is able to yield their time to another individual. All statements shall be directed to the presiding officer; no participant may address or question Board members individually. The following rules for public participants shall apply: time limits will be strictly enforced, no personal attacks on individuals, no vulgar or indecent language, a person may address the Board no more than once during a single meeting, speakers should refrain from naming individuals, and comments or questions posed during public participation will not be debated. As a reminder, this is a meeting of the Board in public, not a meeting of the public."

Mrs. Carvalho excused herself from the meeting at 9:15 p.m.

Mrs. Amin called upon the first public participant, Camilo Victoria, to address the Board.

Camilo Victoria, 19 Elmora Avenue, spoke about the budget.

Mrs. Amin thanked him for his comments and called upon the next public participant, Stephanie Goncalves, to address the Board.

Mrs. Carvalho and Mr. Neron returned to the meeting at 9:18 p.m.

Stephanie Goncalves, 202 Marshall Street, spoke about the fines from the USDA.

Mrs. Amin thanked her for her comments. Mrs. Amin called upon the next public participant, Maria DaRassi, to address the Board.

Maria DaRassi, 336 Franklin Street, spoke about the budget.

Mrs. Amin thanked her for her comments. Mrs. Amin called upon the next public participant, Wally Miranda, to address the Board.

Wally Miranda, 241 Marshall Street, congratulated the Board on the two high schools named top in the nation by U.S. News.

Mrs. Amin thanked him for his comments. Mrs. Amin called upon the next public participant, Debra Kosiarski, to address the Board.

Mrs. Amin thanked her for her comments. Mrs. Amin called upon the next public participant, Christina Moreira, to address the Board.

Christina Moreira, 805 Gebhardt Avenue, spoke about school trips, budget, substitute staffing service, and legal fees.

Mrs. Amin thanked her for her comments. Mrs. Amin called upon the next public participant, Wendy Reina, to address the Board.

Wendy Reina, 189 Keats Avenue, spoke about special education.

Mrs. Amin thanked her for her comments. Mrs. Amin called upon the next public participant, Maria Lorenz, to address the Board.

Maria Lorenz, 103 Murray Street, spoke about special education and substitute staffing services.

Mrs. Amin thanked her for her comments. Mrs. Amin called upon the next public participant, Danette Torres, to address the Board.

Danette Torres, 539 Grier Avenue, spoke about special education.

Mrs. Amin thanked her for her comments. Mrs. Amin called upon the next public participant, James Carey, to address the Board.

James Carey, 212 Inslee Place, made comments about the attorneys for the Board.

Mrs. Amin thanked him for his comments. Mrs. Amin called upon the next public participant, Laura Rico, to address the Board.

Laura Rico, resident, spoke about special education.

Mrs. Amin thanked her for her comments. Mrs. Amin called upon the next public participant, Joseph Cortico, to address the Board.

Joseph Cortico, Elizabeth Education Association Vice President, stated that former Board President Francisco Gonzalez has been chosen and voted to be awarded with the Edward Carey Award for community service on May 28th at the EEA Retirement Dinner and invited all Board members to attend. Mr. Cortico stated that he attended a City Hall meeting two weeks ago and if anyone gets out of hand there they are asked to be removed from the meeting.

Mrs. Amin thanked him for his comments. Since there were no other citizens signed in to address the Board, Mrs. Amin declared this portion of the public meeting closed.

Resolution – Adoption of the 2015-2016 School Year Budget

A motion was made by Mr. Trujillo, seconded by Mr. Perreira, that the resolution be adopted.

Mrs. Carvalho stated that she will be voting no. Mrs. Carvalho stated that she cannot support a resolution that does not cut attorney fees, that continues to use Source4Teachers, and that is cutting back on our police. Mrs. Carvalho stated that she would like to see additional line items in this new year and she would also like a plan to fix our older schools that don't have air conditioning, that need plumbing work, that need bathrooms, and that need just day to day care. Mrs. Carvalho stated that she was not a part of creating this and cannot vote yes for it.

Mrs. Hugelmeyer stated that just for clarification we are not reducing any of the services provided by our Elizabeth Police.

Mrs. Carvalho asked if we are not cutting back on any police services.

Mrs. Hugelmeyer stated that is correct that we are not cutting back on the police services.

Mr. Rodriguez asked when it changed.

Mrs. Hugelmeyer stated that there is no reduction for the services for the Elizabeth Police Department in the budget. Mrs. Hugelmeyer stated that it is noted in the binder.

Mrs. Amin stated that she wanted to say a few words about the budget. Mrs. Amin stated that the process of putting together a budget for a school district is not one that is taken lightly, especially when that process impacts the lives of so many people and the ability to carry out our responsibility of educating our children. Mrs. Amin stated that our Superintendent of Schools Olga Hugelmeyer and her team of administrators have spent countless hours, many times until the wee hours of the morning, making calculations, reviewing department expenditures, and the level of service required to meet the demands and challenges of all of our present students and the projected increase in enrollment. Mrs. Amin stated that in the last few years this district has suffered through a combined zero increase in state and federal aid while experiencing a student body growth of approximately 1,000 students per year. Mrs. Amin stated that this requires an increase in teachers to meet the instructional demands and needs and increases in costs to meet the state and federal obligations of the district. Mrs. Amin stated that this combination of opposing forces was met with fiscally prudent and responsible decisions that resulted in reducing the Elizabeth Public Schools' expenditures by \$38 million for the 2015-2016 school year. Mrs. Amin stated that these same prudent and responsible decisions led to increasing the percentage of

dollars going to instruction from 77% to 79% while decreasing our operational costs from 19% to 17%. Mrs. Amin stated that these numbers reflect a concerted effort by the Superintendent and this Board to consider the fiscal impact of these decisions on educators, support staff, students, and taxpayers. Mrs. Amin stated that in comparison to the City of Elizabeth's budget where the tax levy has increased 18 times in the last 18 years, the Elizabeth Public Schools levy has increased only 5 times in those same 18 years. Mrs. Amin stated that while these 5 increases has led the Elizabeth Public Schools' tax levy to increase by 56%, those increases by the City of Elizabeth has led to a 265% increase. Mrs. Amin stated that considering these challenging and difficult decisions it is disingenuous, at best, and a political ploy at worst, for any elected official whether part of this Board or of the City of Elizabeth to criticize this budget we are here to vote on. Mrs. Amin reminded her colleagues on this Board that they were elected and took a sworn oath to guide the Elizabeth Public Schools to provide the best education possible for the children of Elizabeth and upholding that oath includes being fiscally prudent and responsible to the educators, support staff, students, and taxpayers of Elizabeth. Mrs. Amin stated that this budget accomplishes that. Mrs. Amin thanked Mrs. Hugelmeyer, Mr. Kennedy, Dr. Greene, and the entire administrative team that worked so diligently on this budget.
