# BOARD OF EDUCATION MEETING Approved June 17<sup>th</sup>, Board of Education Meeting

May 7, 2025 Elizabeth, New Jersey

Board President Stanley J. Neron called the meeting to order at 7:02 p.m. and welcomed everyone to the May 7, 2025, regular agenda/business meeting of the Elizabeth Board of Education and read the following statement:

"Good evening and welcome to our Board of Education Meeting of the Elizabeth Board of Education. This is a combined regular agenda and business meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star-Ledger and Cablevision of Elizabeth on May 2, 2025. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth, New Jersey.

"We want to welcome everyone present here at School No. 51 and to our television viewers to this May 7, 2025, meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public.

"This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. So that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking.

We ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, we may have to ask for order periodically should noise begin to interfere with our recording capabilities.

"There will be a public portion for citizens to address the Board. Participants for the public portion must personally sign in prior to the start of the public participation portion so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number, and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Board President Stanley Neron asked Student Representative Mr. Christ Villard to present his report to the community.

Good evening, Board members, Superintendent Dr. Hugelmeyer, Assistant Superintendents, Principals, Vice Principals, Administrators, Teachers, Staff, Fellow Students, and families. My name is Christ Villard, and I am honored to serve as the student representative of Admiral William F. Halsey Health & Public Safety Academy. Tonight, I stand not just as one voice, but as a reflection of many of the vibrant, diverse, and dynamic student body that makes our school truly exceptional. At Halsey Academy, diversity isn't just a statistic-it's a lived experience. Every hallway, every classroom tells a different story. We come from diverse cultures, speak different languages, practice different traditions, and hold different perspectives. Yet it is in that difference that we find strength, creativity, and connection. It's that unique blend of backgrounds and experiences that will prepare us for a future in a global, interconnected world. Halsey provides the space for every student to explore their passions and reach their potential. And that is what I am excited to share more about with you tonight.

Throughout the school year each one of the school's representatives had to collaborate with administrators and teachers to improve our schools and make them a place where everyone feels comfortable and motivated to learn. We recognize that education is essential and that everyone learns differently, so we try to find creative ways to reach everyone in their educational experience. A perfect example of this at Halsey was our Interclass Sporting Event, at which I had the privilege of spearheading. It was more than just a competition-it was a celebration of school spirit and unity. With approximately 1,000 students in attendance, this event brought together students from grade nine through twelve and included staff from Halsey Main and Annex campuses. You got to see students who might not usually interact, all cheering each other on, playing side by side, and representing their class with pride. The positive feedback from students and staff after this event was overwhelming, and it demonstrated how impactful community-centered activities can be in fostering school spirit and unity.

This is just one example of the incredible work we've done together. Our commitment to our school community doesn't stop there. At Halsey we also care about the environment. You can see that in our student-led environmental clubs, recycling initiatives and working in our greenhouse and gardens. These efforts reflect how much students care about making a positive impact, and Halsey students are leading that charge with creativity and passion. We also grow beyond the classroom. In September, Fundraising events throughout the year do not just raise money-they build community. Whether it's for class trips, charity causes, or special school events, they bring students and teachers together for a common goal. Some highlights are:

The Ninth Grade ORT Farm Field Trip & Corn Maze which was an immense success where students learned about biodiversity, climate awareness and sustainability practices. In addition, Halsey hosted visits from universities like Kean University, William Paterson, NJIT, Montclair State, Rutgers (Newark), and Bloomfield College to help us plan our futures. Accordingly, the Ninth-Grade students hosted an HBCU College Fair, organized Thank You Grams for the staff and closed out the year with an impressive Holiday Dance Performance, all of which represent Halsey's commitment to student involvement.

To welcome 2025, we had a Resolution Wall, where students shared their goals for the new year. I am proud to be part of a school that values not just academic success, but personal growth as well. In February, our Volunteer Social Emotional (SEL) Group visited classrooms to help students feel more connected and included. This helped more students join clubs like the National Honor Society, Arts & Music Club, Math Club, and the YES Program. We also had a Hot Chocolate and Cookie Sale to raise money for the Senior Class. Groups like our Honor Societies and leadership clubs offer students a place to connect, belong and build their confidence. We celebrated Black History Month with fun events like a dance show at school, a door-decorating contest, and a dance performance at the Board of Education meeting. We even had Students vs. Students games, which were a big hit with all grades to promote that wonderful school spirit that Halsey has. At Halsey, no one must go through high school alone. One of our most powerful examples of our inclusive spirit is how we celebrate one another, especially during months like Women's History Month. At Halsey, it is not just a calendar event. We decorated classroom doors to honor important women and show how we value the challenging work they did to get where they are today. It's time when we lift the voices, stories, and accomplishments of women in history and our school community. A perfect example of this is celebrating our Girls ROTC Team who did great in the JROTC Fitness Competition, coming in fourth out of fourteen teams. At Halsey Academy, every achievement matters, every voice is valued, and every student has a place.

At Halsey we promote inclusivity, as seen in April where we celebrated Autism Awareness and through the Treat All Peeps with Kindness event, where we promoted kindness and school spirit. Halsey excels at this with our ongoing activities like the Give Someone a Reason to Smile Today Bulletin Board, Daily Shoutouts during Announcements, and weekly R.I.S.E. Shout Outs, which highlight the kindness and character of Halsey students.

In closing, I want to extend my deepest gratitude to the Board of Education and our dedicated school leaders for giving me the incredible opportunity to serve as a student representative. It has been an honor to represent the voices of my peers and to advocate on behalf of Halsey Academy. This year, we have celebrated academic achievements, artistic talents, athletic victories and countless moments of leadership and growth among our peers. Thank you for trusting me with this responsibility and your continued commitment to all Elizabeth students. None of this could have been possible without the support of our amazing staff members and thank you for allowing me to represent a school of which I am so proud. It has been a privilege to serve, and I am excited for the bright future ahead for Halsey Academy and all its students.

Mr. Neron thanked Mr. Villard for his report and applauded all his accomplishments and wished him the very best in the future.

Any person in violation of the Policy will be warned, and their comments terminated if needed. If such violation continues, this individual may be escorted from the meeting."

The committee finalized the review of the SEPAC policy and regulation and recommended them for first reading at the May board meeting.

Based on guidance from Christina Topolosky at the Division of Individual & Family Support Services from Union County, the district cancelled the parent resource fair (originally set for Saturday, May 10) due to a scheduling conflict with a large county-wide event scheduled for that day in Plainfield. Instead, for our second parent event for this school year, the Division of Special Services is surveying our SEPAC parents on their recommendation for a workshop topic. The proposed choices are:

- Post-Secondary Program Options for Students with Disabilities
- Challenging Behaviors: Strategies and Support for Families

The results will be available by Friday, May 9, and will plan for the event to be during the last week of May (virtually). Dr. Ojeda presented to the committee the efforts of the Division of Special Services to recognize all Special Education team-members for their contributions to our students, in recognition of New Jersey School Boards Association *Special Education Week* for 2025. The event will take place this year from Monday to Friday, May 12-16. In addition to recognizing a number of special education programs via our social media platforms, two special events will take place:

• *Thank-A-Paraprofessional Day*. Currently, over 1,000 paraprofessionals serve our students each day in our classrooms. Students will make thank you cards for their paraprofessionals. To assist, the Division of Special Services sent to each school a care package of markers and construction paper.

• Faculty and Staff Appreciation Day. Our schools are full of teachers and other staff who go out of their way each day for students. As part of this day, the Division of Special Services sent each school three faculty/staff appreciation slips per student, as well as instructions to follow for each class. At the start of the day, each student will receive his/her three slips and be asked to recognize any three team-members in the school throughout the day.

Welcome to the Public Hearing on Harassment, Intimidation and Bullying (HIB) and our Student Safety Data System Reporting for the period starting July 1, 2024 and ending December 31, 2024.

In July 2011, the Anti-Bullying Bill of Rights was signed into law as P.L. 2010,

In accordance with this law, all New Jersey public school districts must designate the first full week of October of each year as a "Week of Respect." During the Week of Respect, school districts are expected to organize activities, including but not limited to, age-appropriate instruction and opportunities for student discussion on conflict resolution, issues of diversity, and tolerance.

A resolution was put before the Board in September declaring the week of October 7-11, 2024, Week of Respect. Each of our schools planned appropriate activities for this week.

In fulfilling the reporting requirements pursuant to N.J.S.A. 18A:17-46, two times each year between September 1 and December 31 and between January 1 and June 30, the school board shall hold a public hearing at which the Chief School Administrator will report to the Board of Education and the public any acts of violence, vandalism and harassment, intimidation and bullying which occurred during the previous reporting period.

From September 1, 2024 through December 31, 2024, there were 142 HIB investigations conducted by appropriate school staff. Of those cases investigated, 56 were confirmed cases of HIB. The following Anti-Bullying Specialists, Anti-Bullying Specialist Alternates and Anti-Bullying Coordinator conducted these investigations:

Of the Founded cases for HIB there were 13 incidents based on Race/National Origin, 7 incidents based on Color, 4 incidents based on Sexual Orientation, 2 incidents based on Gender, 2 incidents based on Gender Identity or Expression, 3 incidents based on a Mental, Physical or Sensory Disability and 38 incidents based on other targeted bases.

Of the Founded incidents, 33 incidents were verbal. 19 incidents were physical. And, 9 incidents involved an electronic communication.

For all HIB investigations, there were 46 out of school suspensions, 30 in school detentions, 20 classroom changes, 7 changes of school placement, and 9 administrative counseling sessions.

Additional services such as counseling, skill development sessions, classroom lessons, behavioral interventions, referrals for outside mental health treatment, referrals to outside agencies, and parent conferences were offered to all involved students.

➤ Between September 1, 2024 and December 31, 2024, the district provided appropriate in person and virtual HIB training to school counselors and social workers, and to new staff

and support staff in the district. Additionally, all district certified staff received the 2-hour mandatory virtual HIB training, which is required every 5 school years. The district also provided extensive in person and virtual specified training to the Anti-Bullying Coordinator and to all Anti-Bullying Specialists and their alternates. Non-certificated staff also received training. New school level administrators and new HIB staff received virtual/in-person training in the HIBster reporting program.

- From September 1, 2024, through December 31, 2024 there were 168 substance abuse incidents districtwide. There were 194 incidents of Violence, 22 incidents of Vandalism, and 10 Weapons incidents, which are broken down amongst our 37 schools.

Superintendent Dr. Olga Hugelmeyer presented the H.I.B report for the May Board Meeting.

- 1.) Pursuant to Board Policy 5131.1, Harassment, Intimidation, and Bullying, and New Jersey Statute 18A:37, "The results of each investigation shall be reported to the Board of Education no later than the date of the next board meeting following completion of the investigation and include: 1) Any services provided; 2) Training established; 3) Discipline imposed; or 4) Other action taken or recommended by the chief school administrator."
- 2.) Since our last Board of Education meeting on April 17, 2025, and through April 30, 2025, our school counselors, and school based social workers have completed 25 HIB investigations. Of these investigations 13 cases were Founded for HIB as per New Jersey law. There were 9 males, 17 females, 22 regular education students and 4 special education students that were the alleged victims. There were 22 males, 18 females, 34 regular education students, and 6 special education students that were the alleged offenders. Of the 13 cases Founded for HIB, 1 case was Founded based on Race/National Origin, 3 cases were Founded based on Gender, and 10 cases were Founded based on "Other" identifying characteristics. Of the services provided and actions taken for these investigations, there were 7 skill development lessons/trainings, 22 counseling sessions, 2 referrals for outpatient mental health treatment, 2 changes of classroom, 3 administrative counseling sessions, 9 in school detentions, 16 parent conferences, 2 referrals to outside agencies, 11 out of school suspensions, and 2 cases are continuing to be monitored.
- 3.) The HIB statute further requires that at the next regularly scheduled meeting after board members receive the initial report of HIB investigations, the Board issue a decision, in writing, to affirm, reject, or modify the superintendent's decision pertaining to the 70 cases that were reported to you at the last Board meeting on April 17, 2025. In order for you to do so, the investigation summaries from those investigations which were reported to you at the last board meeting have been provided for your review prior to voting.
