### BOARD OF EDUCATION REORGANIZATION MEETING

January 7, 2025 Elizabeth, New Jersey

The members of the Board of Education met for the purpose of reorganization on Tuesday, January 7, 2025

Reverend Dr. Wanda Lundy pastor of Siloam Hope First Presbyterian Church in Elizabath did the Invocation.

Re-elected Board Member, Charlene Bathelus was sworn in for a new term by the Honorable Judge James Wilson.

Re-elected Board Member, Iliana Chevres was sworn in for a new term by City of Elizabeth, City Council President, Carlos Cedeno.

Re-elected Board Member, Stephanie Goncalves Pestana was sworn in for a new term by the Honorable Judge Jubilo L. Alfonso.

School Business Administrator/Board Secretary Harold E. Kennedy, Jr. read the following statement at 6:45 p.m.
