BOARD OF EDUCATION (Official)

January 5, 2022 Elizabeth, New Jersey

The members of the Board of Education met virtually for the purpose of reorganization on Wednesday, January 5, 2022. In light of the recent trends in reported Covid-19 cases and recently reported increases in the spread of the Omnicron Variant, the Elizabeth Board of Education will conduct the meeting remotely using online platform technology without providing a physical meeting place. Voice conferencing technology for the Wednesday, January 5, 2022 Reorganization Meeting available at 7:00 p.m. was to the public https://www.facebook.com/epsnj and https://www.youtube.com/user/epschools.

School Business Administrator/Board Secretary Harold E. Kennedy, Jr. welcomed everyone to the reorganization meeting of the Elizabeth Board of Education.

Mr. Kennedy called for a moment of silence for the passing of Dwarka Nath Malhotra, father of Comptroller Rajeev Malhotra.

Pledge of Allegiance National Anthem

School Business Administrator/Board Secretary Harold E. Kennedy, Jr. presented the following statement at 7:12 p.m.

"Ladies and Gentlemen, good evening. This is the annual reorganization meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting using an online platform was sent to The Star Ledger and Cablevision of Elizabeth on December 31, 2021. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth, New Jersey.

There will be an on-line public portion for citizens to address the Board. Participants for the public portion must register online up to the start of the meeting so that they may have the opportunity to speak. The public participation form states the name and email of the person who wants to comment. Members of the public who prefer not to, or do not have the means to, participate using the on-line platform, may continue to participate by emailing statements relative to agenda items and/or educational matters to the Secretary of the Board at kennedha@epsnj.org. All statements received will be read into the record during the Meeting's Public Comment Portion. All emails must be submitted and received by the Secretary of the Board up to the start of the meeting and, as is always the case must include the public member's full name for the record. Each statement submitted by a participant shall be limited to three minutes in duration. The total time of public comment shall be limited to 60 minutes. Emails received but not read after the 60-minute duration will be spread in full in the Official Board Minutes of this meeting.

As included in the aforementioned December 31, 2021 public notice of this meeting, the oath of office to the three re-elected Board members, Iliana Chevres, Charlene B. Dorgely, and Stephanie Goncalves Pestana, was previously administered privately via video streaming technology by persons duly authorized to give oaths. The oath is accompanied by a signed certificate required for swearing into office and seating of elected Board members and accordingly qualifies each of them to be seated at this meeting. The oath of office and accompanying certificates will be herby entered into the record of this meeting."

The certificate of oath of office for school board members states that "I do solemnly swear (or affirm) that I will support the Constitution of the United States and the Constitution of the State of New Jersey, and that I will bear true faith and allegiance to the same and to the Governments established in the United States and this State, under the authority of the people. So help me God.* I do solemnly swear (or affirm) that I possess the qualifications prescribed by law for the office of member of a board of education, that I am not disqualified as a voter pursuant to a revised statute N.J.S.A. 19:4-1, that I am not disqualified due to conviction of a crime or offense listed in N.J.S.A. 18A:12-1, and that I will faithfully, impartially and justly perform all the duties of that office according to the best of my ability So help me God.*"

*No individual shall be required to swear or affirm that part of the oaths which states "So help me God."

Superintendent of Schools Olga Hugelmeyer, School Business Administrator/Board Secretary Harold E. Kennedy, Jr., Chief of Operations Francisco Cuesta, and members of the public were in attendance via the online platform.

Mr. Kennedy stated that the Education Act requires that at the organization meeting the Board shall elect from its members a President and a Vice President who shall serve for terms of one year. Nominations will be made from among the membership of the Board present. Elections shall be by the majority of the vote present and voting which means this is the majority of the quorum. When nominations are made, they do not require a second, however, in order to close nominations there must be a motion to second and then a vote to close nominations for the office of President or Vice President.

Mrs. Goncalves Pestana stated that with the pandemic still having a hold on our community she felt like unfinished business remained and was determined to work alongside all of her colleagues once more to help our schools and our community members rise again. Mrs. Goncalves Pestana thanked

the people of the City of Elizabeth for putting their trust in her to serve and give back to this wonderful community that has given so much to her. Mrs. Goncalves Pestana stated that we must continue to work together for the betterment of our children and our City. Mrs. Goncalves Pestana stated that brighter days are ahead for each and all of us and thanked them for allowing her to once again be a part of the team that will help us get there. Mrs. Goncalves Pestana thanked everyone and wished everyone a Happy New Year. Mrs. Goncalves Pestana stated that she hopes 2022 will be a healthy, happy, and rewarding year for us all.

Mrs. Moreno-Ortega thanked them for their comments.

Mrs. Moreno-Ortega stated that first and foremost, she would like to thank her husband, Alejandro, her son Joseph, her daughter Mariana, and her step-daughter Alexandra for their great support in making this moment possible. Mrs. Moreno-Ortega thanked her colleagues who sit beside her on this Board. Mrs. Moreno-Ortega stated that she appreciates their trust in her to take on this responsibility and looks forward to building upon the success we have achieved in recent years as a Board and as a school district. Mrs. Moreno-Ortega stated that there are many great challenges ahead and knowing that she is surrounded by such exceptional and dedicated people, she is confident that we will continue to succeed.

Mrs. Moreno-Ortega stated that it is a great honor to serve the Board in this capacity and further share her passion for education. Mrs. Moreno-Ortega stated that since 2004, she has been a Spanish teacher for Jersey City Public Schools. Mrs. Moreno-Ortega stated that during her seventeen years of teaching, she has been fortunate enough to help grow the World Language standard in Jersey City and develop a multicultural club at her school. Mrs. Moreno-Ortega stated that both of these achievements focused on creating an environment of inclusion where various cultures and unique personal journeys are learned from, valued, and celebrated. Mrs. Moreno-Ortega stated that as a Board member, she has always sought to use that same approach to tap into the diversity of our students, team members, and families to bring out the greatest strengths and traits of our learning community.

Mrs. Moreno-Ortega stated that as a Board member, an experienced educator, and mother of multiple children, she views the current educational environment through multiple sets of lenses. Mrs. Moreno-Ortega stated that she finds herself asking how the Elizabeth Public Schools and her as a teacher can provide a high-quality education that will prepare students for future success as well as what measure should schools take to keep all members of their learning community physically and emotionally healthy. Mrs. Moreno-Ortega stated that those perspectives guide her two top priorities which are closing the achievement gap through providing a high standard of education during evolving circumstances and maintaining the safest and healthiest instructional environment possible to protect the well-being of all members of our learning community.

Mrs. Moreno-Ortega stated that school districts everywhere have always been determined to close achievement gaps within their learning communities. Mrs. Moreno-Ortega stated that however, the impact Covid-19 has had on the delivery of instruction during the past couple of years has created a significant concern that those gaps could widen. Mrs. Moreno-Ortega stated that the recent surge in positive cases indicates the pandemic continues to have a major presence and will continue to affect education in our community, our nation, and the world. Mrs. Moreno-Ortega stated that we must work relentlessly both to prevent achievement gaps from widening and to determine and apply every practice we can to continue closing them.

Mrs. Moreno-Ortega stated that we have made so many great strides in our efforts to continue delivering an excellent education to our students during these difficult times. Mrs. Moreno-Ortega stated that one thing she has found as an educator to be consistent through both in-person and remote instruction is that effective teaching is flexible and engages students' learning styles, interests, prior knowledge, socialization needs, areas of comfort, and personal culture. Mrs. Moreno-Ortega stated that it is imperative that we remain flexible in finding the way forward and adapting instruction to the circumstances in which we find ourselves.

Mrs. Moreno-Ortega stated that she can assure you that we will continue to do everything in our power to keep our students learning in-person in their classrooms while providing the safest environment possible to protect the health of our students, team members, and families. Mrs. Moreno-Ortega stated that for our students to learn at their best, our teachers and administrators to educate at their best, and for our entire learning community to perform at its best, it is important that everyone feels safe in their environment.

Mrs. Moreno-Ortega stated that our custodial, security, and plant and property teams have all done a remarkable job during the past year and beyond to give our students and team members the safest environment possible for teaching and learning to thrive. Mrs. Moreno-Ortega stated that it is vitally important that we continue to focus on this so all members of our learning community who step into our schools and offices feel safe, valued, and in a position to perform at their best.

Mrs. Moreno-Ortega stated that there is no doubt the pandemic will continue to affect the ways in which we educate our students. Mrs. Moreno-Ortega stated that it will continue to be our task to adapt and thrive in this shifting environment. Mrs. Moreno-Ortega stated that our teachers and administrators continue to do exceptional work in determining new and innovative ways to provide our students with high quality instruction while navigating these challenging circumstances.
