BOARD OF EDUCATION (Official)

October 12, 2017 Elizabeth, New Jersey

The regular meeting of the Board of Education was called on October 12, 2017 at 6:30 p.m., in the MultiPurpose Room, Donald Stewart Center for Early Childhood Education School No. 51, 544 Pennsylvania Avenue, Elizabeth, New Jersey.

Board Vice President Maria Carvalho presented the following statement at 6:50 p.m.

"Ladies and Gentlemen, good evening. This is a regularly scheduled meeting of the Board of Education. Pursuant to New Jersey Statutes and the rules adopted by the Board of Education, notice of this meeting was sent to The Star Ledger and Cablevision of Elizabeth on October 6, 2017. In addition, this notice is posted on the Bulletin Board in the lobby of 500 North Broad Street, and pursuant to this act, a copy has been filed with the City Clerk of Elizabeth, New Jersey.

"We want to welcome everyone present and our television viewers to this October 12, 2017 meeting of the Board of Education. We are here to govern, provide management oversight, and make policy for the district. The Superintendent manages the district. This is a meeting of the Board in public, not a meeting of the public.

"This meeting is being recorded and will become part of the Elizabeth Board of Education permanent record. In order that the recording will adequately reflect the proceedings, please refrain from talking while others are speaking. We also ask that you silence the sound on your electronic devices. Since it is legally mandated that these proceedings be accurately recorded, we may have to ask for order periodically should noise begin to interfere with our recording capabilities. We are pleased that you have taken time this evening to join us here for our Board of Education meeting. Thank you for your interest in the Elizabeth Public Schools."

"There will be a public portion for citizens to address the Board. Participants for the public portion may sign in up to the start of the public speaking so that they may have the opportunity to speak. The sign-in sheet states the name, address, telephone number and reason that the person wants to comment, whether it is an agenda item or a general education comment."

Pledge of Allegiance

Mrs. Carvalho called for a moment of silence for all the victims of Las Vegas, Puerto Rico, and California. Mrs. Carvalho stated that Board President Stanley Neron was not in attendance due to a family engagement.

Board Vice President Carvalho presented the following public participation statement.

"At this time, the microphones are open for public comment to those who have signed in. I shall call individuals to the microphones based on the order of the sign-in. Each statement made by a participant shall be limited to three minutes in duration. The total time of public comment shall be limited to sixty minutes. No individual is able to yield their time to another individual. All statements shall be directed to the presiding officer; no participant may address or question Board members individually. The following rules for public participants shall apply: time limits will be strictly enforced, no personal attacks on individuals, no vulgar or indecent language, a person may address the Board no more than once during a single meeting, speakers should refrain from naming individuals, and comments or questions posed during public participation will not be debated. As a reminder, this is a meeting of the Board in public, not a meeting of the public."

Mrs. Carvalho called upon the first public participant, Michelle Santos, to address the Board.

Michelle Santos stated that she this is the second time she is speaking about a transportation problem with her child being on the bus for an extended time and that there is no camera on the bus.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Elizabeth Youri, to address the Board.

Elizabeth Youri spoke about a problem with her child.

Mrs. Hugelmeyer requested the parent give her information to Assistant Superintendent for Schools Rafael Cortes.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Christina Moreira, to address the Board.

Christina Moreira, 805 Gebhardt Avenue, thanked the district for implementing SEPAC. Mrs. Moreira stated that there were two bus accidents in one day and the parents don't know how to submit the claims. Mrs. Moreira stated that no one has the answer for the \$250. fee charged for a bus for a field trip.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Kathy Colon, to address the Board.

Kathy Colon stated that her child was sent home from school due to the excessive heat in the classroom at School No. 15 and asked how it affects the attendance policy. Ms. Colon stated that she was told that all fans had to be removed from the classrooms.

Mrs. Hugelmeyer explained the procedures during hot weather and children are brought to cooling areas of the building. Mrs. Hugelmeyer stated that each school has an attendance committee to review the reasons for absences.

Mrs. Carvalho thanked her for her comments and requested she give her information to Assistant Superintendent for Schools Rafael Cortes. Mrs. Carvalho called upon the next public participant, Michelle Vila, to address the Board.

Michelle Vila spoke about the excessive heat at School No. 15 and that the principal requested fans but none were given.

Director of Plant, Property, and Equipment Luis Couto stated that when School No. 15 requested the fans we did not have any to give.

Mrs. Hugelmeyer requested she give her information to Assistant Superintendent for Schools Rafael Cortes.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Maria Lorenz, to address the Board.

Maria Lorenz, 103 Murray Street, spoke about the empty promises made by Board members and that the Board majority uses special needs only for political gain.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Kason Little, to address the Board.

Kason Little, student, asked for everyone to have a moment of silence for a student who died on Sunday. Mr. Little spoke about the lack of air conditioning and stated that it is not a safe environment. Mr. Little stated that the Board members should be here to represent us.

Mrs. Carvalho thanked him for his comments. Mrs. Carvalho stated that there are 12 schools without air conditioning and we are working towards having all schools air conditioned but we need to budget for it. Mrs. Carvalho called upon the next public participant, Priscilla Borges, to address the Board.

Priscilla Borges stated that her child had heat exhaustion at School No. 15 and spoke about the lack of air conditioning and that the cooling center is not the answer. Ms. Borges stated that she was at the school for parents' night and at 6:00 p.m. it was 89 degrees on the second floor of the school.

Mrs. Hugelmeyer requested the parent give her information to Assistant Superintendent for Schools Judy Finch Johnson.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Salaam Ismial, to address the Board.

Salaam Ismial, 513 Richmond Street, United Youth Council, stated that another former student was shot dead. Mr. Ismial spoke about gun violence awareness and stated that he submitted proposals and has not seen enthusiasm from this Board on this matter. Mr. Ismial stated that he wanted to have a Youth Fest in October and the month is almost over so it's not going to happen. Mr. Ismial stated that he would like to meet with the committee of the Board or the Superintendent to work out the proposals. Mr. Ismial stated that a lot of black boys have been dying and he has a team of people ready to help.

Mrs. Carvalho asked Mr. Ismial to speak with Interim Assistant Superintendent for Human Resources Frank Cuesta.

Mr. Ismial responded that you have all of the information.

Mrs. Carvalho thanked him for his comments and called upon the next public participant, Ana Texeira, to address the Board.

Ana Texeira, 575 Second Avenue, stated that this is not the first time speaking about the lack of air conditioning at School No. 15. Ms. Texeira stated that the first time was in 2014 and she was told it was a difficult task. Ms. Texeira stated that the parents were not informed that only the Board could provide fans for the classrooms and asked why the Board did not provide fans. Ms. Texeira stated that she would like to know the protocol so you can purchase fans for the Spring. Ms. Texeira stated that the Board members say that they are here for the children and to help the children and asked how long do we have to wait.

Mrs. Hugelmeyer stated that there are 12 schools left without air conditioning. Mrs. Hugelmeyer stated that each year the Board discusses this and there is a plan for all schools to be air conditioned.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Giovanna LaRosa, to address the Board.

Giovanna LaRosa, 532 Second Avenue, spoke about the lack of air conditioning at School No. 15.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Reina Clavel, to address the Board.

Reina Clavel stated that her son is at School No. 26. Mrs. Clavel spoke about problems with special services and her son was injured at school last week.

Mrs. Hugelmeyer requested the parent give her information to Assistant Superintendent for Teaching and Learning Jennifer Cedeno. Mrs. Hugelmeyer stated that the incident will be properly investigated.

Mrs. Carvalho thanked her for her comments and called upon the next public participant, Barbara Hernandez, to address the Board.

Barbara Hernandez stated that her daughter is at Thomas Jefferson Arts Academy and questioned the teacher to student ratio for high school. Ms. Hernandez stated that there are 31 children in the Algebra class and it is unfair for the teacher and students.

Mrs. Hugelmeyer stated that they will look into the ratio and review with the principal. Mrs. Hugelmeyer stated that the typical ratio is 25 or 26 students in a class.

Mrs. Carvalho thanked her for her comments. Since there were no other were no other public participants signed in to address the Board, Mrs. Carvalho closed this portion of the meeting.

Vice President Maria Carvalho stated that this is an agenda setting meeting. Mrs. Carvalho stated that we will go tab by tab and each Board member may ask questions.
