### CONTRACT WITH IN-LINE HEATING & AIR CONDITIONING CO.

As recommended by Luis R. Couto, Director of Plant, Property and Equipment, that the Elizabeth Board of Education enter into a contract with In-Line Heating & Air Conditioning Co., Bayonne, NJ, for the installation of an air conditioning and ventilation system for the main office & nurse's office at STEM Academy School 92 (under The Educational Services Commission of New Jersey Co-op ESCNJ Bid # 19/20-13), in an amount not to exceed \$67,432.88, as provided in accordance with the provisions of N.J.S.A.18A:18A-10.

**AUTHORIZING BOARD PRESIDENT AND ADMINISTRATOR TO EXECUTE TWO  
LEASES FOR SCHOOL PURPOSES LOCATED AT 209 PRINCETON ROAD  
AND 943 BOND STREET**

**WHEREAS**, the Board is in need of educational space to expand educational activities for Elizabeth Public Schools; and

**WHEREAS**, the Board desires to lease property located at 209 Princeton Road, Elizabeth New Jersey; and 943 Bond Street, Elizabeth, New Jersey (the “Properties”); and

**WHEREAS**, the Board desires to authorize the approval of leases between the Board, as a tenant, and the Archdiocese of Newark, as landlord, with terms substantially similar to those terms as included in the Leases (**Exhibit A**).

**NOW, THEREFORE, BE IT RESOLVED** by the Elizabeth Board of Education as follows:

1. The aforesaid recitals are incorporated herein as if set forth at length; and
2. Jerry D. Jacobs, Board President, and Harold E. Kennedy, Jr., School Business Administrator/Board Secretary, be and are hereby authorized and directed to execute the approved Leases, attached hereto; and
3. All previous Resolutions and/or orders and directives of Board employees or officials, which are contrary or inconsistent with the terms of this instant Resolution, are hereby rescinded, repealed and otherwise deemed ineffectual, to the extent of their inconsistency.
4. This Resolution shall take effect immediately.
