WHEREAS, Rose Perone taught at a parochial school for a year before returning to Elizabeth Public Schools in 1952 to start her long career in education with the district, first serving as a sixth-grade teacher at the former Elias Boudinot School No. 9, and

WHEREAS, during her years of teaching, Rose Perone also served as an ESEA teacher during many summers, taking on the responsibility of raising the academic achievement of struggling learners and addressing the complex challenges that arise for students who live with disability, learning difficulties, poverty, or language barriers, and

WHEREAS, Rose Perone eventually was appointed as principal of Elias Boudinot School No. 9 in 1972, where she helped create a nurturing and caring learning environment for teaching and learning to flourish while ensuring daily activities and building operations ran smoothly, and

WHEREAS, the Elizabeth Board of Education approves the use of Capital Reserve Funds in the amount of \$25,000.00 for use in the 2021-2022 capital projects budget to cover the escrow funding of Benedictine Academy associated with the Capital Project Plan.

NOW, THEREFORE, BE IT RESOLVED, by the Elizabeth Board of Education that it hereby authorizes the district's School Business Administrator/Board Secretary to make this transfer consistent with all applicable laws and regulations.
