**BOARD OF EDUCATION****RESOLUTION****AUTHORIZING ENTRY INTO A FIVE-YEAR LEASE/PURCHASE AGREEMENT  
WITH CITY NATIONAL CAPITAL FINANCE, INC.  
FOR THE LEASE/PURCHASE OF FIVE SCHOOL BUSES**

**WHEREAS**, the Board, having determined that, as a result of a reduction in the number of buses available to the District as a result of their reaching the end of their service life, has determined that it is in the best interests of the District to acquire an additional five school buses to put into service in order to safely transport students to and from school related activities; and

**WHEREAS**, a Request for Bids was initiated on February 9, 2018 with the aid of the Hunterdon County Educational Services Commission for the purpose of financing the acquisition of the additional five buses; and

**WHEREAS**, the Bid Opening was conducted on February 22, 2018 in accordance with N.J.S.A. 18A:18A-4.5d which opening resulted in the submission of two (2) responses; and

**WHEREAS**, an evaluation report of the bid was prepared by the Hunterdon County Educational Services Commission, a copy of which is attached hereto, recommending City National Capital Finance, Inc. as the lowest responsible bidder, to be approved as the leasing company for the financing of the lease of the five school buses.

**NOW, THEREFORE, BE IT RESOLVED** by the Elizabeth Board of Education, as follows:

1. The aforesaid recitals are incorporated herein as if set forth at length.
2. City National Capital Finance, Inc. located at 25 W. Flagler Street, Miami, Florida 33130 is deemed qualified to provide the lease financing necessary to lease/acquire five school buses previously identified for acquisition.
3. The Board authorizes entry into a leasing agreement pursuant to the terms of the Master Lease Purchase Agreement with exhibits, attached hereto and authorizes and directs the Board President and School Business Administrator/ Board Secretary to execute the same in normal fashion. The attached Agreement provides for a lease term of five years at a lease rate of 2.89% with an initial payment of \$100,000.00 due at closing, followed by five annual payments of \$59,187.74 commencing August 1, 2018, and a final lease payment of \$152,246.78 due and payable on August 1, 2023.
4. All previous Resolutions and/or orders and directives of Board employees or officials which are contrary or inconsistent with the terms of this instant Resolution are hereby rescinded, repealed and otherwise deemed ineffectual to the extent of their inconsistency.

**BOARD OF EDUCATION****RESOLUTION****QUALIFYING AND APPOINTING NUENERGEN, LLC FOR ENERGY  
MANAGEMENT – TRACKING, PROCUREMENT AUDITING AND DEMAND  
RESPONSE SERVICES FOR DISTRICT SCHOOLS**

**WHEREAS**, as the Board’s current contract for District-wide energy management, tracking, procurement and demand response services (the “Services”) expires on March 20, 2018, the Board, at its January 18, 2018 regular meeting, authorized the Business Administrator to issue a Request for Proposals (“RFP”) for a new contract for the Services with a goal for the continued reduction of energy costs for District facilities; and

**WHEREAS**, the RFP was initiated on January 24, 2018 utilizing the competitive contracting process in compliance with the Public School Contracts Law; and

**WHEREAS**, the Bid Opening was conducted on February 13, 2018 in accordance with N.J.S.A. 18A:18A-4.5d which opening resulted in the submission of two (2) responses; and

**WHEREAS**, Luis Couto, Director, Plant, Property and Equipment, recommends that the Board enter into a contract for the Services for an initial term of one (1) year, in the form attached hereto, with NuEnergen, LLC, the lowest responsible bidder, in an amount not to exceed Sixty-Nine Thousand and No/100 Dollars (\$69,000.00) (Energy procurement services not to exceed \$60,000 for the term and EnerTrac Dashboard & Budget Services not to exceed \$9,000 for the term), plus Demand Response Services equal to thirty-five percent (35%) of program revenue generated for the District, plus Invoice and Auditing Services equal to twenty-five percent (25%) of funds recovered; and

**NOW, THEREFORE, BE IT RESOLVED** by the Elizabeth Board of Education as follows:

1. The aforesaid recitals are incorporated herein as if set forth at length; and
2. **NuEnergen, LLC**, located at 10 Bank Street, White Plains, New York 10606 is deemed qualified to provide the Services.
3. **NuEnergen, LLC** is appointed to be the company to provide energy management, tracking, procurement and demand response services as assigned by this Board or its designee in accordance with Board policy.

4. The Board approves the contract attached hereto and authorizes and directs the Board President and Board Secretary/School Business Administrator to execute the same in normal fashion. The attached contract provides for a term not to exceed one year (with two options to renew for additional one year terms), at a cost not to exceed \$60,000.00 for the initial term for Energy Procurement Services, \$9,000 for the initial term for EnerTrac Dashboard & Budget Services (for a total not to exceed \$69,000.00), plus Demand Response Services equal to thirty-five percent (35%) of program revenue generated for the District, plus Invoice and Auditing Services equal to twenty-five percent (25%) of funds recovered on behalf of the District.
